- (j) The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for.

On failure to do so, CNLU shall have the right to forfeit the entire amount of the bidder.
- (n) Final decision to accept/reject the bids shall be taken by the CNLU on the basis of eligibility criteria and highest financial quote.

## **Criteria to award:**

- a. The items shall be sold to the highest bidder. The bids are invited for the lot (i.e. all the items contained in the list of obsolete/unserviceable furniture/ electronic & electrical scrap and other items at Annexure "A" as a whole and no bid would be accepted for any part of the same.
- b. The reserve price of entire lot under disposals is Rs. 50,000/- (Fifty Thousands). The offer below reserve price may summarily be rejected.
