

**Instructions for admission for B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.)  
Course for the Academic Year 2017-2018 under Foreign  
Nationals/NRIs/NRI Sponsored Category**

Out of a maximum of 140 seats for B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) Courses 10 seats will be allotted to Foreign Nationals and 10 seats are allotted to NRIs/NRI sponsored candidates. The unfilled seats in Foreign Nationals Category are allotted to NRIs/NRI Sponsored Candidates.

The applications for direct admission to B.A., LL.B.(Hons.) / B.B.A., LL.B.(Hons.) Courses for the Academic Session 2017-18 under Foreign Nationals / NRIs / NRI Sponsored Categories be sent directly to the University along with the duly filled in application forms, other relevant documents and prescribed fees.

*The candidates under Foreign Nationals / NRIs shall be admitted directly on the basis of their 10+2 / Intermediate marks.* However, applications under NRI Sponsored Category shall be considered for direct admission of those candidates only who have appeared for CLAT 2017. They shall send the filled in application forms along with the copy of the admit card of CLAT 2017, other relevant documents and prescribed fees. They shall be admitted as per their Merit Rank in CLAT 2017.

Candidates of the above mentioned categories shall fulfill other requirements regarding age and qualifications as per CLAT-2017 and CNLU eligibility Regulations. The candidate should be below 20 years of age as on 1<sup>st</sup> July 2017. The merit list of Foreign Nationals / NRIs will be determined on the basis of their 10+2 marks. If the merit is still the same then the marks of 10<sup>th</sup> standard will be taken into consideration. If still there is no change in rank then the higher in age shall get preference.

Candidates who wish to apply under Foreign Nationals Category/ NRIs/NRI sponsored category shall submit the duly filled in application forms which can be downloaded from our Website [www.cnlu.ac.in](http://www.cnlu.ac.in) with all supporting documents along with DD for Rs. 7,500/- drawn in favour of **Registrar, Chanakya National Law University, Patna**, payable at Patna on or before **Wednesday the 5<sup>th</sup> July 2017**. Selected candidates should complete the admission formalities by paying required fees on the scheduled dates to be announced in the University Website: [www.cnlu.ac.in](http://www.cnlu.ac.in)

NOTE: Unfilled seats, if any, in Foreign Nationals and NRIs / NRI sponsored categories will be filled in as per the Bihar Act No. 16 of 2003.
