## **Admission Notice (Fifth Allotment List)**

To

The First Year Students, B.A., LL.B. (Hons.) Degree Course/ B.B.A., LL.B. (Hons.) Degree Course, Academic Year 2022-23.

Dear Students, Greetings from CNLU!

- (A) For candidates who have chosen the option of Revise/Accepted from fourth allotted list prepared on 16th July, 2022 by Consortium of National Law Universities, Bengaluru.
  - Revise/Accepted Candidates of fourth allotment list who took admission from any of the previous allotted lists prepared by Consortium of National Law Universities, Bengaluru need not to pay first year fee of Rs. Rs. 1,98,470/- (One Lakh Ninety Eight Thousand Four Hundred Seventy only) in the case of General Category candidates who have already paid Rs. 30,000/- to CLAT Consortium, 2022; and Rs. 2,08,470/- (Two Lakhs Eight Thousand Four Hundred Seventy only) in the case of ST/ SC/ EBC/ BC/ EWS/ PWD candidates to our University because they have already paid to National Law University from where they have been upgraded from the previous allotment lists.
  - They don't have to upload scanned copy of their academic certificates since they have already uploaded on the Consortium Portal.
- (B) Newly allotted candidates in the fifth allotment list prepared on 19th July, 2022:

Based on performance at the CLAT-2022 Examination held on 19th June, 2022, the candidate of National Law Universities, Bengaluru, for counselling for admission in the Five Year Integrated B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) Degree course at Chanakya

National Law University, Patna are directed to pay Rs. 1,98,470/- (One Lakh Ninety Eight Thousand Four Hundred Seventy only) in the case of General Category candidates who have already paid Rs. 30,000/- to CLAT Consortium, 2022; and Rs. 2,08,470/- (Two Lakhs Eight Thousand Four Hundred Seventy only) in the case of ST/ SC/ EBC/ BC/ EWS/ PWD candidates, who have already paid Rs. 20,000/- to CLAT Consortium, 2022. Payment has to be made through following ICICI Bank Payment Gateway on date directed by Consortium of National Law Universities, Bangaluru i.e. on or before 20th July, 2022 till 09:00 p.m. as directed by Consortium of National Law Universities, Bengaluru.

## (C) For Newly Allotted Candidates in the Fifth Allotment List:

Candidates shall have to **upload** the **scanned copies** of following documents as given below on CLAT Consortium Portal, 2022 only within the **stipulated time as given by the Consortium of National Law Universities, Bengaluru:-**

- 1. Original Matriculation Certificate or Marks-Sheet where Date of Birth is clearly mentioned for verification of Date of Birth;
- 2. Marks Sheet of Matriculation/10<sup>th</sup>;
- 3. Marks Sheet of Intermediate / 10+2 (Candidates for whom the result of XII standard are yet to be announced should submit an undertaking stating they will submit marks statements for XII standard or any equivalent Marks statement within 07 days of the announcement of results).
- **4.** Caste Certificate issued by competent authority of Govt. of Bihar (*Applicable for the reserved category candidates only*), if applied and allotted under the reserved category.
- **5.** Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2021-22) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category.
- **6.** Admit Card of CLAT-2022.
- 7. PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.

At the time of admission all admitted students shall have to bring original copies of all the above-mentioned documents.
