Syllabus for 'subject specific' for Ph.D. Entrance Test -2021.

Part-E: Subject Specific.

As a broad guidelines, the UGC syllabus for NET/JRF shall be the syllabus for all subjects: **Law, Political Science, Economics, Management, English literature**, and those who have opted inter-disciplinary research, their subject specific test will be in their Post-graduation (PG) subject ,as syllabus prescribed for UGC NET/JRF.

For Law students, here is certain subject mentioned for test e.g. Jurisprudence, Constitutional Law, Contract Law, Specific Relief and Equity Law, Administrative Law, Labour Code, Economic Laws, International Law, Criminal Laws, Environmental Laws, Consumer Protection Law, Human Rights Law along with Current SOCIO-LEGAL Developments, Supreme Court and High Court Judgements/Ratios.

Note: But it is not exhaustive. In addition to the above mentioned subjects in law, the candidates are advised to consult the UGC syllabus for NET/JRF also, for wider coverage.

The pattern of questions for subject specific shall be as:--

- 1. Objective multiple choice questions: 10 Questions of one marks each= 10x1=10
- 2. Very Short Answer Question: 5 Question for two Marks (Max 150 words) each- 5x2=10.
