(Academic Session-2023-24)

[DATE OF ADMISION: 10th January 2024.]

All the successful candidates in Ph.D. (Result declared on 22nd December 2023) for the Academic Session 2023-24, are hereby informed that for taking admission in their respective program, they have to come in person for admission on 10th January 2024 at 11am in the Registrar's office along with the followings:

- a) All the Candidates will bring Migration Certificate, NOC (If employed) and Letter of Recommendation from any professor.
- b) Ph.D. Candidates have to bring Demand Draft of Rupees 63,000/- (Rupees sixty three thousand), In favour of Registrar, Chanakya National Law University, Payable at Patna. This includes –Admission fee, Facilitation fee, Library fee, Library deposit fee, Retention fee and Course work fee, etc for the session 2023-24.
- c) The Candidates who are employed must bring NOC from their respective employer that he/she has been granted leave for Ph.D. Course work (Minimum six months to one year), failing which the candidate shall not be allowed admission. Such candidate shall forfeit their opportunity. No further request shall be entertained in this regards.


