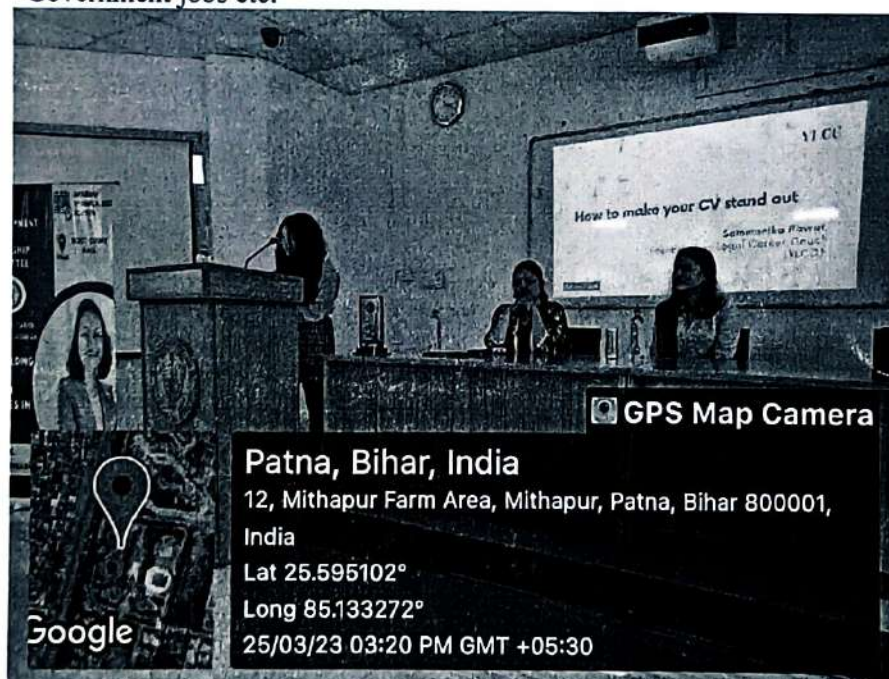

International Day of Yoga – 21st June 2022

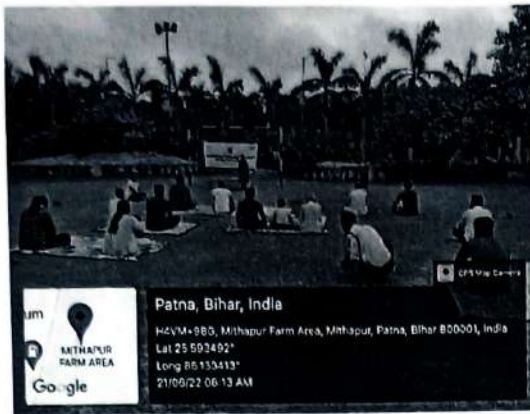
