- The title of the paper should be followed by Name, Designation, Name of the Organization / University / Institution and Email address. It is mandatory to mention Email address as all future correspondence will be through it. The title of the manuscript should be clear and precise.
- Name and details of Co-author, if any.
- The paper should be typed in MS WORD format (preferably 2010)
- The paper must be in single column lay out with margins justified on both sides.
- Word limit of Abstract is 300 (Words).
- The sub heading should be in font size 12, bold and Times New Roman. The length of paper should not exceed 6,000 words (including footnotes). Exceeding the word limit may lead to rejection of papers.
- All references must be in the form of footnotes with font size 10 and should be according to the Bluebook 19th Edition. Publication Opportunity.
- No plagiarism is allowed.
- The paper should not have been previously presented or published.
- Submit soft copy at the email address.
- Papers accepted for the conference will be published in book form bearing ISBN Number.
