Notice

University is receiving e-mails and telephonic calls from the students from which it appears that there is some confusion or misunderstanding regarding room rents in hostels as well as mess charges in the present Academic Sessions 2021-2022.

Following are Room rents, Electricity charges and Mess charges for this Academic Year.

1) Room Rent:-

<u>SI. No.</u>	<u>Hostel Rooms</u>	<u>Charges</u>
1.	For double seated room with double occupancy	Rs. 16000/ each student per annum
2.	Room rent for double seated room with single occupancy	Rs. 16000/ + Rs. 12000/ each student per annum
3.	Room rent for single room	Rs. 16000 + Rs. 6000/-

Note: The above mentioned Room rent in the hostels are for the whole Academic Year but this year only the students will be charged room rent on pro-rata basis.

2) **Electricity Charges:-** Electricity charges for the whole session is rupees 5000/-. But for this Academic Year 2021-2022 electricity charges will be taken on the pro-rata basis.

Air-conditioner and Air-cooler:- Some students have their personal air-conditioner or air-cooler in their respective room with the permission of the university and they used to pay the electricity charge for the air-conditioner or air-cooler also. Following are the charges of air-conditioner/air-cooler for one Semester (Vide letter no. CNLU/45(a)/2018-1991 dated 29.11.2018).

<u>Heads</u>	<u>Air-Conditioner</u>	<u>Air-Cooler</u>
Electricity Charge	Rupees 6000/- (One Semester)	Rupees 1200/- (One Semester)

Note: The above mentioned electricity charges for air-conditioner/air-cooler are for one Semester but in the present Semester concerned students shall have to pay the above mentioned charges on pro-rata basis.

3) **Mess Charges:-** University Vide letter no. CNLU/45(a)/2021-541 dated 19.08.2021 had informed the students that old mess contractor has placed two conditions to run the mess which are as follows:-

- i) That he will not be able to provide food facilities in case number of students in hostels is less than 70, then in that case boys/girls in the hostel will have to make their own arrangements for food.
- ii) The mess contractor has given representation that the prices of grocery and edible items have increased much so he cannot provide food in the old rates which was prevalent before COVID pandemic and he has requested for 10% hike in the mess charges.

Considering the request of the mess contractor as well as other circumstances the university has enhanced the mess charges by 10% which comes to about Rs. 3350/- per month.

The students have to pay the mess charges @ rupees 3350/- per month on pro-rata basis.

Note: - All the students who are going to occupy the hostel in this Academic Session shall have to pay the room rent, electricity charges for the Academic Year and mess charges in advance before occupying the hostel. At the end of the session after calculating the above charges on pro-rata basis the balance amount will be returned to the concerned students.
