(Hons.)/B.B.A., LL.B. (Hons.) Degree course at Chanakya National Law University, Patna are directed to pay Rs. 1,98,470/- (One Lakh Ninety Eight Thousand Four Hundred Seventy only) in the case of General Category candidates who have already paid Rs. 30,000/- to CLAT Consortium, 2022; and Rs. 2,08,470/- (Two Lakhs Eight Thousand Four Hundred Seventy only) in the case of ST/ SC/ OBC/ BC/ EWS/ PWD candidates, who have already paid Rs. 20,000/- to CLAT Consortium, 2022. Candidates shall have to **upload** the **scan copies** of following documents as given below on CLAT Consortium Portal, 2022 only within the **stipulated time as given by the Consortium of National Law Universities, Bengaluru:-**

1. Transfer / Migration Certificate (Candidate who has appeared in 2022 CBSE/ICSE Exam and Transfer / Migration Certificate has not been issued by Competent Authority till date would submit at the time of Admission)

- 2. Character/Conduct Certificate from the institution last attended indicating that he/she has never been found guilty of misconduct during the study period;
- **3.** Original Matriculation Certificate or Mark-Sheet where Date of Birth is clearly mentioned for verification of Date of Birth;
- **4.** Marks Sheet of Matriculation/10<sup>th</sup>;
- 5. Marks Sheet of Intermediate / 10+2 (Candidate who has appeared in 2022 CBSE/ICSE Exam and Marks-Sheet of Intermediate / 10+2 has not been issued till date would submit at the time of Admission)
- **7.** Caste Certificate issued by competent authority of Govt. of Bihar (*Applicable for the reserved category candidates only*), if applied and allotted under the reserved category.
- **8.** Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2021-22) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category.
- **9.** Admit Card of CLAT-2022.
- **10.** PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.

At the time of admission all admitted students shall have to bring original copies of all the above-mentioned documents.
