Examination Notice

Considering prevalent nature and spread of COVID 19, it is felt that the current situation is alarming. COVID 19 has magnified the stress and anxiety of the students in unprecedented manner. It has left the students in a state of uncertainty. To mitigate the suffering of students and ease their burden it is imperative on our part that we stand and empathise with them even in matters of Examinations.

The UGC has responded to this crisis and framed certain guidelines to meet this exigency. Universities across the country have been given autonomy and flexibility to meet the challenges in their own way by evolving a mechanism that adequately addresses issues of organizing Exams during COVID-19 pandemic. In order to reduce the adverse impact of pandemic and to facilitate the students, a policy is being which is least detrimental and is conducive to all, is hereby notified.

This mechanism shall be applicable only for the Academic Session 2019-2020 (January 2020 to April 2020).

I. CNLU End Semester Examination Policy for the LL.M. Course for the Semester ending in April 2020, (Academic Year 2019-2020)

COVID 19 Pandemic & Subsequent Lock Downs from **March 2020** has made it increasingly difficult to conduct End Semester Examinations in its physical / traditional form.

Considering the interest of present 2nd Semester Students of LL.M., it is as per the directives of the UGC, that the LL.M. students will appear in their End Semester Examination through online mode.

If any of the above-mentioned students have Backlog papers and if there are Detained students in the above-mentioned Semesters, then such students shall appear in End Semester Examination through online mode in the respective papers.

Hence, Examination will be conducted online for the above-mentioned students.



However, the 2nd Semester students of LL.M., who fail to appear or who are unable to pass in the End Semester Examination held through online mode, shall get an opportunity to appear in the Repeat End Semester Examination to be conducted after reopening of the University. In the interest of such students it is further notified that ® shall not be affixed to their grade sheet if they appear and pass the concerned paper in the above mentioned Repeat End Semester Examination.

All such students of present Academic Year (2019-2020) from **January 2020 to April 2020** will be deemed to have attended their classes. In case of backlog papers and detained students the attendance marks already obtained by the students in their respective subjects shall be carried forward.

II. CNLU Contingent End Semester Examination Policy for the B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) Courses for the Semester ending in April 2020

Considering the interest of above said courses of present semester students, UGC and BCI directions have been followed as alternative mode of promotion and finalisation of Semester Results.

The promotional scheme for the students of B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) courses of **Second, Fourth, Sixth, Eighth and Tenth Semesters** as well as the students appearing in Backlog papers and Detained Students:

1. All such students of current batches of Second, Fourth, Sixth, Eighth & Tenth Semesters in Academic Year (2019-2020) will be deemed to have attended their classes. In case of backlog papers and detained students the attendance marks already obtained by the students in their respective subjects shall be carried forward.
2. Mid Semester Examination of 15 Marks has already been held.
3. Project Assignments of 20 Marks have already been notified and is being evaluated. (Please refer Annexure- I)

In Promotional Scheme for the above-mentioned students, marks obtained in Mid Semester and project assignments shall be added and will be rationalized with full marks, i.e., 95 marks for a given Subject as per the formula illustrated below:

Example 1: If student 'A' has obtained 10 Marks in Mid Semester and 16 Marks in Project Work, 'A' has obtained 26 Marks out of 35. The rationalization shall be $\frac{26}{35} \times 95 = 70.57$, the round off Marks shall be 71 and therefore, 'A' has obtained 71 Marks out of 95. Marks of attendance is 5. The total marks obtained by 'A' is 76 and the Grade is D.

Example 2: If, 'B' has obtained 11 Marks in Mid Semester and 13 Marks in Project Work, 'B' has obtained 24 Marks out of 35. The rationalization shall be $\frac{24}{35} \times 95 = 65.14$, the round off Marks shall be 65 and therefore, 'B' has obtained 65 Marks out of 95. Marks of attendance is 5. The total marks obtained by 'B' is 70 and the Grade is A++.

However, the students, who are unable to pass any paper as per the above scheme, shall get an opportunity to appear in Repeat End Semester Examination after reopening of the University. In the interest of such students it is further notified that ® shall not be affixed to their grade sheet if they appear and pass the concerned paper in the above mentioned Repeat End Semester Examination.


Special Scheme for the Seminar and Clinical Papers of Semester X

The Seminar papers, viz., **Seminar Paper III:** Health Law and **Seminar Paper IV:** Law Relating to Women and Child; and **Clinical Paper IV:** Moot Court Exercise and Internship shall be evaluated as per the scheme already notified by the University, vide its notice dated 22nd May, 2020 on its website. In the interest of such students it is further notified that ® shall not be affixed to their grade sheet if they pass the paper by resubmitting the project at the time of the above mentioned Repeat End Semester Examination.


Students who have already submitted the project report and made the presentation will be awarded out of 25 and 20 marks respectively based on their report and presentation.

A. SCHEDULES FOR (CLINIC-IV, MOOT COURT EXERCISE AND INTERNSHIP)

All the students of 10th Semester are hereby informed regarding the schedules for the submission of **Clinic Paper IV Drafts** as follows:

1. The students have to submit their **Client-Counselling Report** for which the students will get the problem from the concerned faculty. The **Client-Counselling Report** shall be submitted through E-mail to the concerned faculty in typed or handwritten format on or before **30th June 2020** and they shall be awarded marks based on the evaluation of **Client-Counselling Report** submitted by them for **35 Marks**.
2. The students have to also submit the project report for which the topic has been already assigned by the concerned faculty. The project report should be within the word limits of **4000-5000 words** and shall be submitted through email to the concerned faculty in typed or handwritten format on or before **30th June 2020**. They shall be awarded marks based on the evaluation of **Project Report** submitted by them for **60 Marks**.

B. SCHEDULES FOR (SEMINAR –III, HEALTH LAW & SEMINAR –IV, LAW RELATING TO WOMEN AND CHILD)

All the students of 10th Semester are hereby informed regarding the schedules for the submission of **Seminar Paper (III & IV) Drafts** as follows:

1. The students have to also submit the **Synopsis** of the project report for which the topic has been already assigned by the concerned faculties.
2. The **Synopsis** shall be submitted through E-mail to the concerned faculties in typed or handwritten format on or before **15th June 2020** and students shall be awarded marks based on the evaluation of **Synopsis** submitted by them for **35 Marks**.
3. The **Final Project Report** (within the word limits of **4000-5000 words**) shall be submitted through **E-mail** to the concerned faculty in typed or handwritten format on or before **30th June 2020**. They shall be awarded marks based on the evaluation of **Project Report** submitted by them for **60 Marks**.
