## ADMISSION NOTICE AGAINST THE VACANT SEATS AT CNLU, PATNA FOR

B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) COURSE, ACADEMIC YEAR- 2022-23

Candidates who appeared in the CLAT-2022 Examination held on 19<sup>th</sup> June, 2022 which was organised by the Consortium of National Law Universities, Bengaluru for admission and are *willing* to take admission to B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) Course in our University against few vacant seats / against the subsequent vacancy, if any, can apply under the following categories:

- (i) General Category (only those candidates should apply under General Category whose All India Rank in CLAT-2022 Examination is up to 3000 (Three Thousand only);
- (ii) Backward Classes (BC-II) for Bihar Domicile only whose All India Rank in CLAT-2022 Examination is up to 7,000 (Seven Thousand only) (Right now there is no vacant seat in BC-II Category but in future, if any, subsequent vacancy exists admission would be taken);
- (iii) Extremely Backward Classes (EBC) for Bihar Domicile only whose All India Rank in CLAT-2022 Examination is up to 13,000 (Thirteen Thousand only) (Right now there is no vacant seat in EBC Category but in future, if any, subsequent vacancy exists admission would be taken);
- (iv) \*Women of Backward Classes (WBC) for Bihar Domicile only whose All India Rank in CLAT-2022 Examination is up to 8,000 (Eight Thousand only) (Right now there is no vacant seat in WBC Category but in future, if any, subsequent vacancy exists admission would be taken);
- (v) Economically Weaker Sections (EWS) for Bihar Domicile only; whose All India Rank in CLAT-2022 Examination is up to 6,000 (Six Thousand only) (Right now

- there is no vacant seat in EWS Category but in future, if any, subsequent vacancy exists admission would be taken);
- (vi) Scheduled Caste (SC) for Bihar Domicile only (Right now there is no vacant seat in SC Category but in future, if any, subsequent vacancy exists admission would be taken);
- (vii) Person with Disability (PWD).

\*Under WBC category, women candidates of Bihar from (i) Extremely Backward Classes (BC-I), (ii) Backward Classes (BC-II), (iii) Scheduled Caste (SC) and (iv) Scheduled Tribe (ST) can only apply.

Interested candidates can apply against the Vacant Seats at CNLU, Patna, for B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) Course, Academic Year- 2022-23 through the following Google Form link (Sample of needed data for Google Form and documents is enclosed):

Please note that if Rs. 38,000/- (Thirty Eight Thousand) is not paid within the above mentioned date i.e on or before 25<sup>th</sup> July, 2022 till 05:00 p.m., the candidature of candidate shall not be considered for admission. No further enquiry shall be entertained in this regard.

Such candidates will be informed about probability of their admission, subject to vacancy and in order of their All India Rank of CLAT-2022 result, through our website time to time. Subsequent vacancies, if any, shall be filled in also by *only* those candidates who will apply till 25<sup>th</sup> July, 2022 by 05:00 p.m.

The first list against the vacant seats would be published on 28<sup>th</sup> July, 2022 on the University website i.e. <a href="http://cnlu.ac.in">http://cnlu.ac.in</a> and admission of the provisionally selected candidates would be taken through online mode from 28<sup>th</sup> July, 2022 to 30<sup>th</sup> July, 2022.

At the time of online admission, the candidate shall have to pay the remaining fee i.e. Rs. 1,90,470/- (One Lakh Ninety Thousand Four Hundred Seventy only) for the first year through the above mentioned ICICI payment gateway link.

Mere depositing payment of Rs. 38,000/- (Thirty Eight Thousand) does not guarantee admission. In case of vacancy, provisional admission will be given after thorough verification of the documents of the candidates. However, if any document is found to be false or incorrect at any point of time, the admission shall stand cancelled automatically.

The candidates, whose admission is not confirmed till the closure of admission (last date of admission will be notified on our website), or who want to withdraw their candidature and request for the refund, are hereby informed that their paid amount of Rs. 38,000/- (Thirty Eight Thousand) will be credited to their bank account which is provided by the candidates in the Google Form after seven (07) days of the closure of the admission.

If all seats of B.A., LL.B. (Hons.) Course of Academic Year 2022-23 gets filled-in then admission will be taken in B.B.A., LL.B. (Hons.) Course. In case all seats of B.B.A., LL.B. (Hons.) Course of Academic Year 2022-23 gets filled-in then admission will be taken in B.A., LL.B. (Hons.) Course.
