5. The bidder shall be bound to follow the restriction on the movement of labour, materials imposed by any other authority connected with the site due to security or any other reasons connected with the event. No claim shall be entertained on this account.
6. The bidder shall take all precautions to avoid accidents by exhibiting necessary cautions boards, lights, flags etc. and ensure that no hindrance is caused to the traffic. He shall be responsible for all damages, accidents, caused due to negligence.
7. The bidder shall be fully responsible for the safe custody of the material.
