IMPORTANT NOTICE

Considering the request for reopening of the hostels for the students of 3rd, 4th and 5th year students and also, after examining all relevant issues and circumstances the University administration has decided to re-open the boys and girls hostel for 3rd, 4th & 5th year students only from **5th of September, 2021** on the following conditions:

- I. The classes will continue to be held on virtual/online basis but examination will be on offline mode.
- II. During the term of the student's stay, they shall have free access to the hostel room allotted to them and limited access to the academic block, Library and other common spaces.
- III. The students will maintain social distancing, wear masks whenever out of their rooms and follow all other guidelines as provided for COVID-19.
- IV. All the students coming back to the campus will have to get tested for COVID-19 and bring a copy of the report of them being negative. The test should have been done within 72 hours of their arrival.
- V. The student will bring with them his/her vaccination certificate.
- VI. The students will also quarantine for 7 days in their rooms after their arrival, if required, after that, they shall be allowed to go to the library or the academic or administrative block.
- VII. The students may only leave campus to buy essential commodities like food, medicine etc.
- VIII. The students shall wear masks at all times they will be outside their hostel rooms.
- IX. Even while visiting the library the students will maintain social distancing and will wear masks at all times.
- X. Time slots can be made for the students for going to the mess. They will also wear masks in the mess and take the food to their rooms.
- XI. Students opting for hostel shall have to pay the hostel fees in advance and also they have to pay the mess charges in advance as agreed between them and the mess contractor.

- XII. If any student wants to meet with any faculty, he/she shall take an appointment with the concerned faculty beforehand.
- XIII. The students will also abide by any other instructions or guidelines set by the university to prevent the spread of the virus.
- XIV. The hostel workers who are responsible for cleaning the rooms will only do so on alternatively days and while they are cleaning the rooms the student will be outside the room.

Note:- *Since the old mess contractor has placed two conditions to run the mess which are as follows:-*

- i) *That he will not be able to provide food facilities in case number of students in hostels is less than 70, then in that case boys/girls in the hostel will have to make their own arrangement for food.*
- ii) *The mess contractor has given representation that the prices of grocery and edible items have increased much so it cannot provide food in the old rates which was prevalent before COVID pandemic and he has requested for 10% hike in the mess charges.*
