Course Title: Company Law

Course Overview

This is an elementary introductory course in Company Law. The main source of statutory

material, the Companies Act, 2013 contains over 470 sections, VII Schedules and Rules. It is for

students approaching company law for the first time, and assumes no prior knowledge on the

part of students. The curriculum is designed to focus on behind the corporate veil; constitutional

matters, the duties and liabilities of directors; shareholders' rights and remedies, contracting with

the company, corporate transparency, and theoretical introductions to the company and corporate

governance. Students seeking more advanced corporate law modules should choose

Specialization (Honours) Course as Corporate Law.

Module one deals with features of the law and its evolution and provide an insight into how the

legislation works, how it falls to be construed, and how far it succeeds in its actual or apparent aims.

Module two focuses on Incidents of corporate personality. Differences between incorporated and

unincorporated associations. The rule in Salomon v Salomon & Co Ltd and its development. Tortious

liability as an alternative to veil lifting.

Module three deals with the provision of limited liability (though one can have separate legal

personality without limited liability, as in the unlimited liability company). Although 'limited liability'

is a well-known phrase, at least three (not necessarily mutually exclusive) meanings can be attached to

it. At its narrowest, limited liability means that that claims of the company's business creditors cannot

be asserted against the assets of the shareholders.

Module four covers the nature of and principles governing the statutory contract between the company

and its members. Different capacities of members and relations between one member and another. Alteration of the statutory contract and remedies for breach.

Module five covers the general duties of directors, and the codification of those duties. Statutory controls on directors, including rules on self-dealing and the criminalization of insider trading. The enforcement of directors' duties, including rule in **Foss v Harbottle** and the statutory derivative claim. Company disclosure and investigations by the Department for Business, Energy and Industrial Strategy.

Module six deals with the statutory remedies for the protection of minority shareholders. Shareholders' personal rights, including under the statutory contract.

Learning Outcomes

The course aims to give students an introduction to Company Law and to enable them to gain knowledge of its main features and some of its specific 'technical' rules; to analyse and evaluate this knowledge; and to gain some understanding of how corporate law operates in practice in the commercial world

On completion of the course, students will be able to:

- 1. Understand the core principles of company law.
- 2. develop their analytical faculties by identifying and resolving legal issues relating to the operation of companies in terms of the relationship between the board of directors and the General Meeting
- 3. develop their critical faculties by evaluating the rules, policies, and principles of Indian company law
- 4. evaluate legal materials and effectively apply them to practical corporate problems;
