Scope of work

The scope of work shall include the following work:

- Maintenance of CCTV Surveillance System Network (Optical Fibre and Cable) & all equipment such as Cameras, Switches, PoE switches, Power Injectors, Media Converters, NVRs / DVRs and HDDs etc during contract period.
- Service provider will clean all equipment on **monthly** basis during contract period. Daily report of status of network and all equipment will be submitted to University.
- Footage of cameras shall be handover to University, Patna during the working hours of University, if demanded.
- If CCTV Surveillance System Network (Optical Fibre and Cable) will become malfunctioned then service provider shall repair it immediately and change the Fibre patch cable, CAT6 patch cable, connectors & other (if required), no payment will be made by University for such work. **University will purchase the new Fibre cable & HDPE Pipe, if required to change, from local market / service provider. University will also pay for digging work, if required.**

If equipment of CCTV Surveillance System such as Cameras, Switches, PoE switches, Power Injectors, Power cables / adapters / SMPS, I/O Box, Media Converters, NVRs / DVRs, and HDDs etc become malfunctioned then service provider immediately informed the matter to Registrar, CNLU, Patna with repairing / replacement cost. Service provider shall provide the equipment in standby till the purchasing / repairing of such equipment takes place.
- f. University will provide electrical power to equipment through UPS.

- VII. **All the risks of personal injury and death of staff of service provider which may arise during and in consequence of the performance of the contract will be the responsibility of the service provider.**
- VIII. The contract initially will be for a period of one year from the date of award notified by CNLU, Patna.
