Greetings from CNLU !

Based on performance at the CLAT-2023 Examination held on 18<sup>th</sup> December, 2022, the candidates who are provisionally selected by the Consortium of National Law Universities, Bengaluru, for counselling for admission in the Five Year Integrated B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) Degree course at Chanakya National Law University, Patna are directed to pay **Rs. 1,78,470/-** (One Lakh Seventy Eight Thousand Four Hundred Seventy only) in the case of **General Category** candidates who have already paid Rs. 50,000/- (30,000 Counselling Registration Fee and 20,000 for Confirmation Fee) to CLAT Consortium, 2023; **and Rs. 1,88,470/-** (One Lakh Eighty Eight Thousand Four Hundred Seventy only) in the case of **ST/ SC/EBC/ BC/ EWS/ PWD candidates**, who have already paid Rs. 40,000/- (20,000 Counselling Registration Fee and 20,000 for Confirmation Fee) to CLAT Consortium, 2023.

**Payment has to be made by the students who have chosen the Freeze option in the first two allotment list (18<sup>th</sup> January & 27<sup>th</sup> January, 2023) they are hereby directed to pay the University tuition fee from 10<sup>th</sup> May, 2023 to 20<sup>th</sup> May, 2023 through following ICICI Bank Payment Gateway :**

Candidates shall have to **upload** the **scan copies** of following documents as given below on CLAT Consortium Portal, 2023 only within the **stipulated time as given by the Consortium of National Law Universities, Bengaluru :-**

1. Transfer / Migration Certificate\*
2. Character/Conduct Certificate from the institution last attended indicating that he/she has never been found guilty of misconduct during the study period;\*
3. Original Matriculation Certificate or Mark-Sheet where Date of Birth is clearly mentioned for verification of Date of Birth;
4. Marks Sheet of Matriculation/10<sup>th</sup>;
5. Marks Sheet of Intermediate / 10+2\*
6. Caste Certificate issued by competent authority of Govt. of Bihar (*Applicable for the reserved category candidates only*), if applied and allotted under the reserved category.
7. Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2022-23) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category.
8. Admit Card of CLAT-2023.
9. PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.

**\* Candidate who will be appearing in 10+2 examination of 2023 would submit their certificate at the time of admission.**

**At the time of admission all admitted students shall have to bring original copies of all the above-mentioned documents along with one set photo copies, failing which their admission will stand cancelled.**
