Dear Students, Greetings from CNLU!

Based on performance at the CLAT-2023 Examination held on 18th December, 2022, the candidates who are provisionally selected by the Consortium of National Law Universities, Bengaluru, for counselling for admission in the Five Year Integrated B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) Degree course at Chanakya National Law University, Patna are directed to pay Rs. 1,78,470/- (One Lakh Seventy Eight Thousand Four Hundred Seventy only) in the case of General Category candidates who have already paid Rs. 50,000/- (30,000 Counselling Registration Fee and 20,000 for Confirmation Fee) to CLAT Consortium, 2023; and Rs. 1,88,470/- (One Lakh Eighty Eight Thousand Four Hundred Seventy only) in the case of ST/ SC/EBC/ BC/ EWS/WBC/PWD candidates, who have already paid Rs. 40,000/- (20,000 Counselling Registration Fee and 20,000 for Confirmation Fee) to CLAT Consortium, 2023. Payment has to be made by those students who have chosen the Freeze/Float options in the third allotment list (Published on 25th May, 2023) and they are hereby directed to pay the above mentioned University fee from 25th May, 2023 to 30th May, 2023 up to 10:30 p.m. through following ICICI Bank Payment Gateway:

failing which their claim of admission in Academic Year 2023-24 would be forfeited.

Note: Those candidates who have chosen the option on Freeze for CNLU, Patna in First and Second Allotment list and have already paid University fee at CNLU, Patna shall not pay again.

Candidates shall have to **upload** the **scan copies** of following documents as given below on CLAT Consortium Portal, 2023 only within the **stipulated time as given by the Consortium of National Law Universities**, Bengaluru. Those students who have already uploaded scan copies of the following documents at Consortium Portal need not upload again:-

- 1. Transfer / Migration Certificate\*
- 2. Character/Conduct Certificate from the institution last attended indicating that he/she has never been found guilty of misconduct during the study period;\*
- **3.** Original Matriculation Certificate or Mark-Sheet where Date of Birth is clearly mentioned for verification of Date of Birth;
- **4.** Marks Sheet of Matriculation/10<sup>th</sup>;
- 5. Marks Sheet of Intermediate / 10+2\*
- **6.** Caste Certificate issued by competent authority of Govt. of Bihar (*Applicable for the reserved category candidates only*), if applied and allotted under the reserved category.
- 7. Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2022-23) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category.
- 8. Admit Card of CLAT-2023.
- **9.** PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.

\*Candidates who will be appearing in 10+2 examination of 2023 would submit their certificate at the time of admission.

At the time of admission (date will be notified in the third week of June, 2023) all admitted students shall have to bring original copies of all the above-mentioned documents along with one set photo copies, failing which their admission will stand cancelled.
