

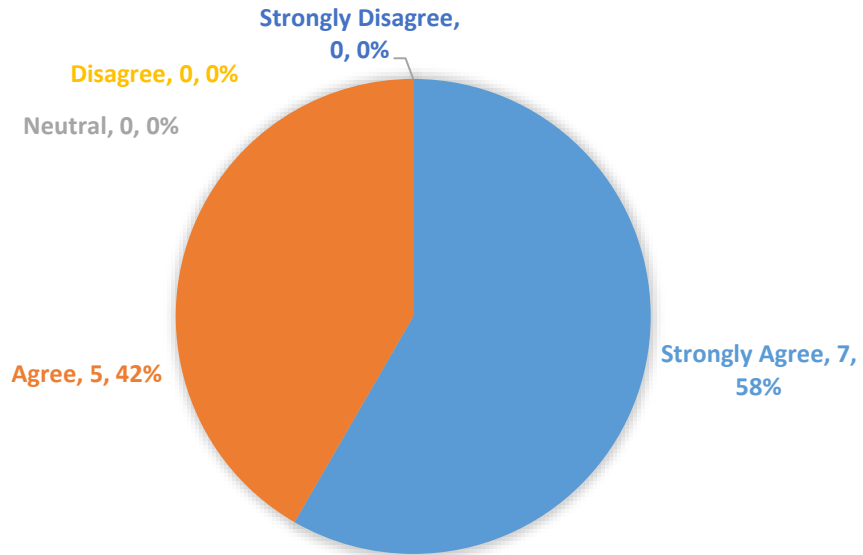

Academic Year 2021-22**

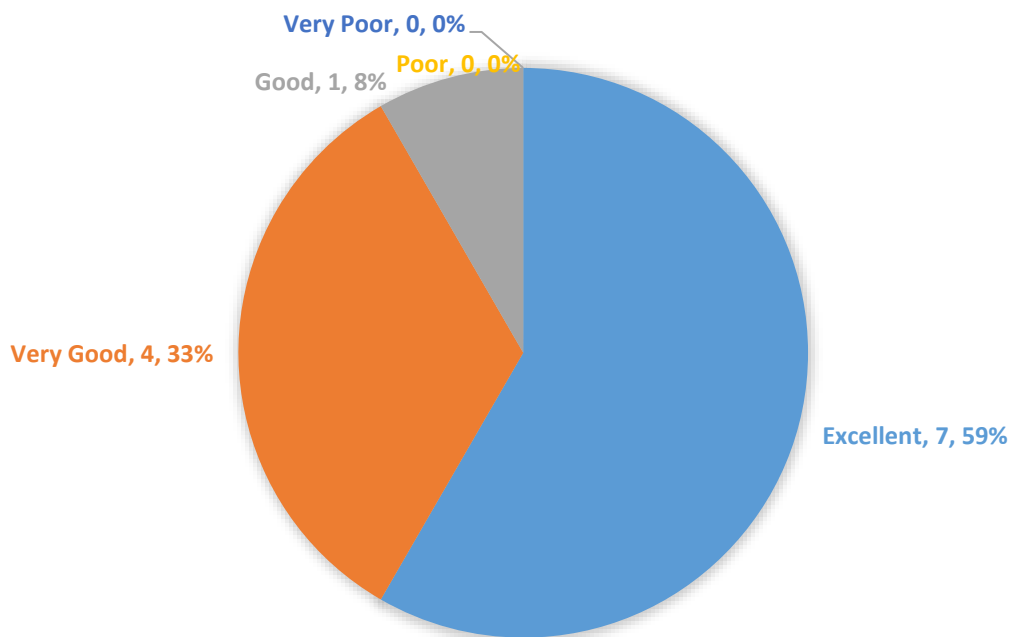
As part of the University's initiative of getting the feedback and opinion of various stakeholders on the syllabus of different courses offered by the University during the Academic Year 2021-22, teacher's feedback were collected. The initiative intends at getting the suggestions of the faculty members as stakeholders for enriching the curriculum and among other things enhancing the employability of the students. The feedback form comprised of ten questions out of which eight questions were objective in nature, covering significant aspects such as, relevance of the syllabus and curriculum for the local, national, regional and global developmental needs, course structure, number of courses, achievement of the desired learning outcomes, overall quality of the syllabus, focus upon the employability and entrepreneurship skills, integration of the crosscutting issues relevant to professional ethics, gender, human values, environment and sustainability into the curriculum and coverage of the fundamentals as well the latest developments in the field for preparing the graduates for the highly competitive job market. Two questions were open ended questions that aimed at eliciting suggestions from the teachers for the review of the syllabus and inclusion of any other aspect in the feedback form.

A total of 12 teachers had filled up the feedback form. Their response was saved and analysed. Detailed report of the teacher's feedback is given below:

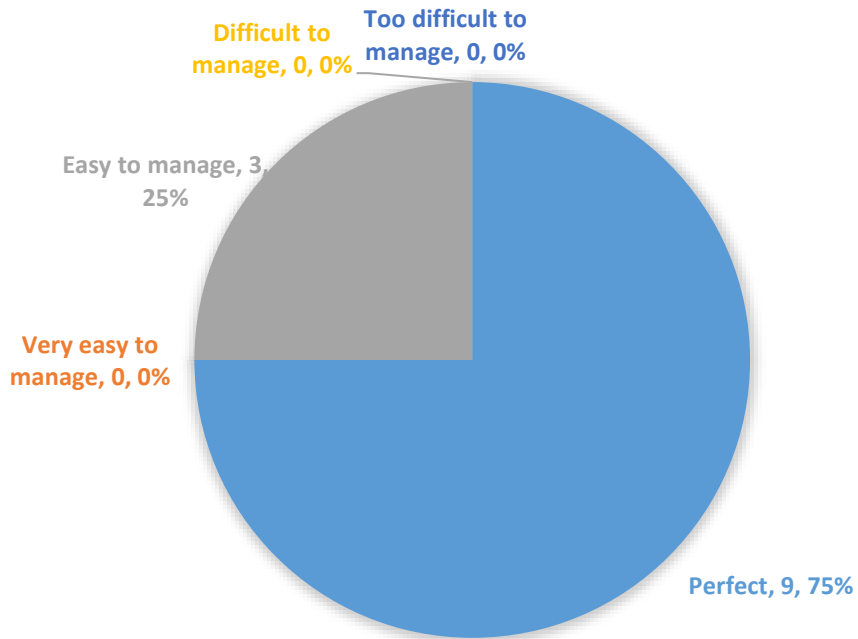

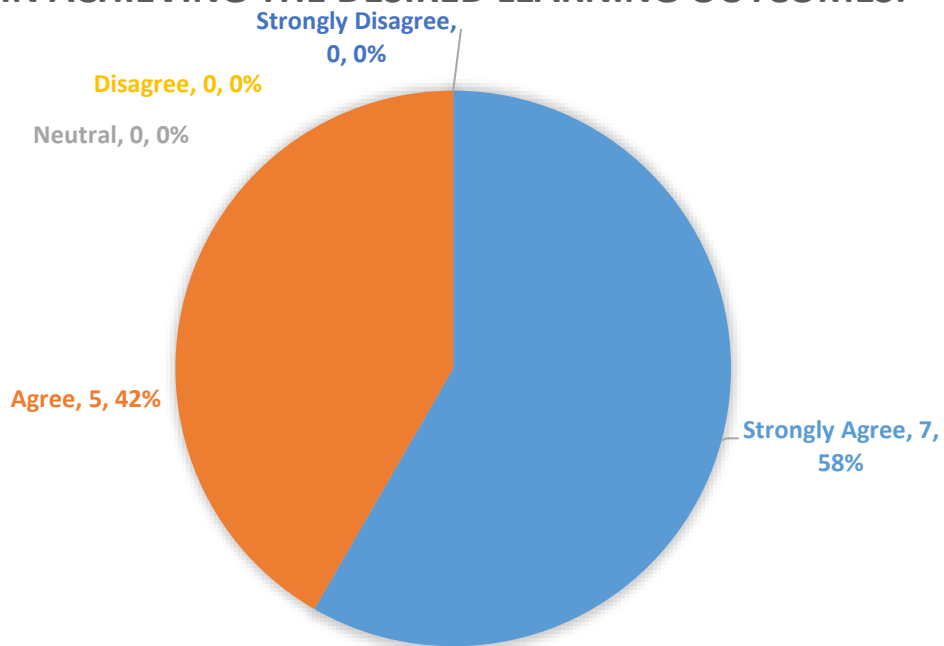
COURSE STRUCTURE OF THE PROGRAMME OFFERED BY THE UNIVERSITY ARE



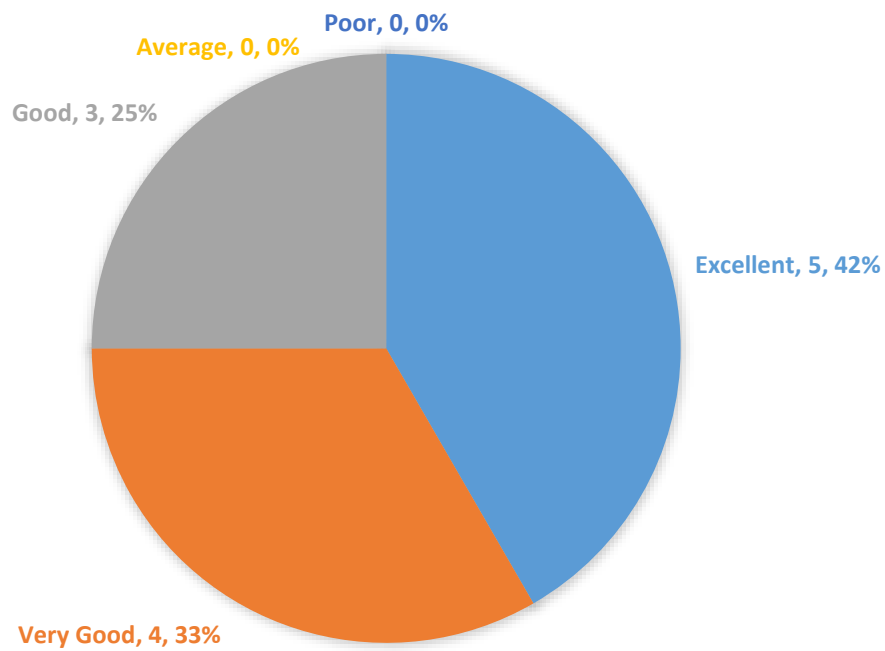
NUMBER OF COURSES IN IN EACH SEMESTER IS



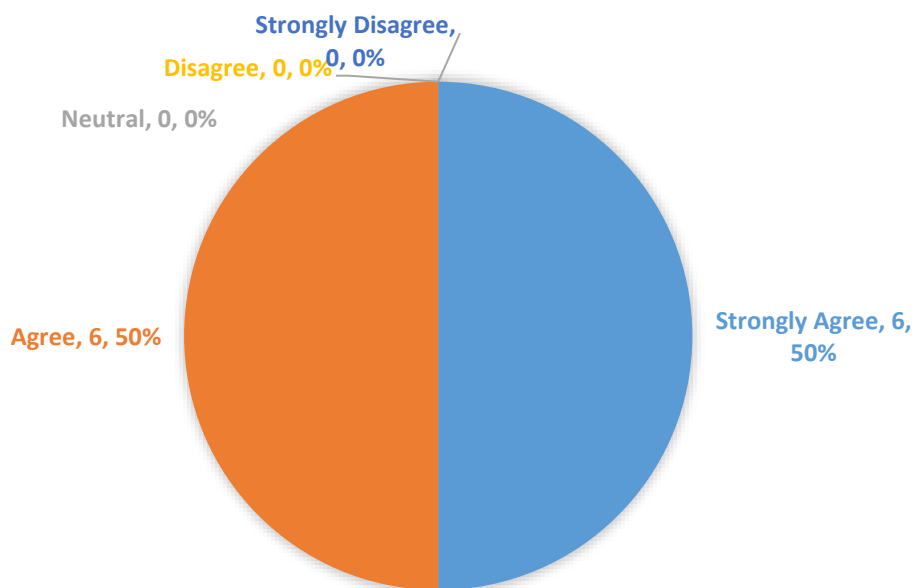
THE CURRICULUM OF THE COURSES ARE HELPFUL IN ACHIEVING THE DESIRED LEARNING OUTCOMES.



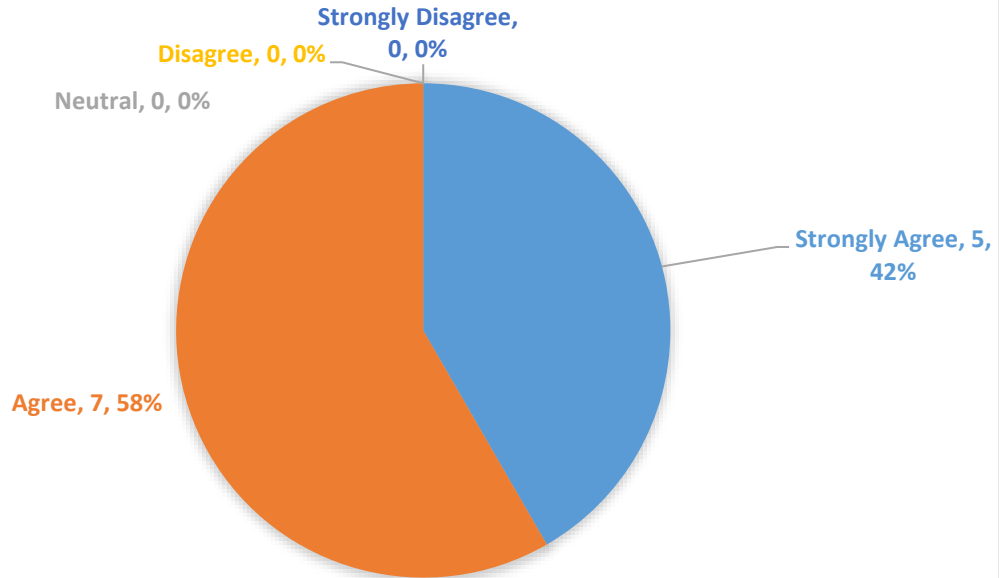
OVERALL QUALITY OF THE SYLLABUS OF THE COURSES



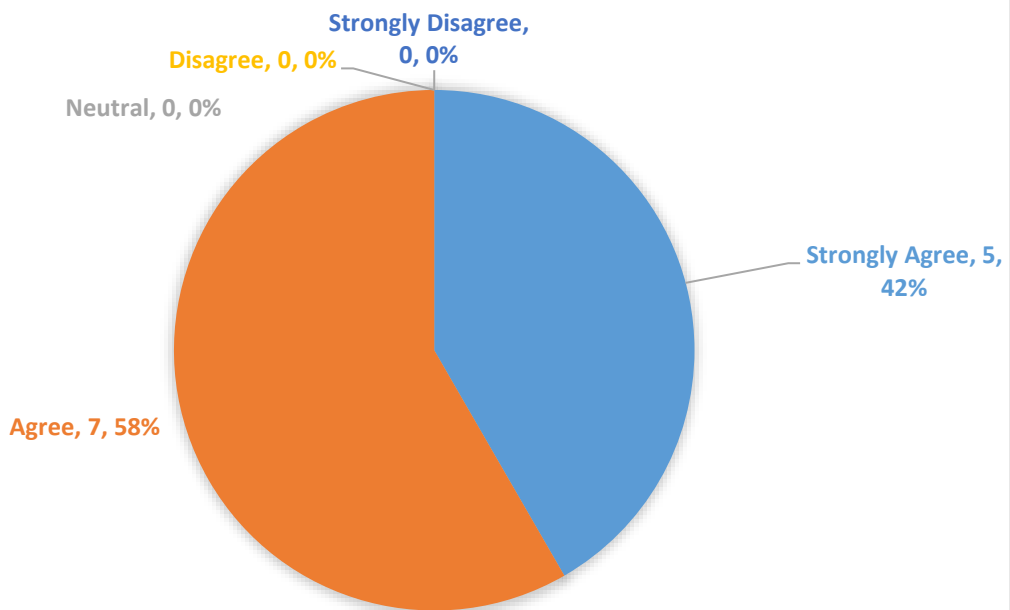
