Greetings from CNLU !

Based on performance at the CLAT-2023 Examination held on 18<sup>th</sup> December, 2022, the candidates who are provisionally selected by the Consortium of National Law Universities, Bengaluru, for counselling for admission in the Five Year Integrated B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) Degree course at Chanakya National Law University, Patna **are directed to pay University fee of CNLU, Patna as per details given below in the box:**

<b>Payment for ST/ SC/ EBC/ BC/ EWS/ WBC/ PWD candidates</b> , who have already paid Rs. 20,000/- as Counselling Registration Fee to CLAT Consortium, 2023. ➡	<b>Rs. 2,08,470/-</b> (Two Lakh Eight Thousand Four Hundred Seventy only)
<b>Payment for ST/ SC/EBC/ BC/ EWS/ WBC/ PWD candidates</b> , who have already paid Rs. 40,000/- (20,000 as Counselling Registration Fee and 20,000 for Confirmation Fee) to CLAT Consortium, 2023. ➡	<b>Rs. 1,88,470/-</b> (One Lakh Eighty Eight Thousand Four Hundred Seventy only)

**Payment has to be made by those students who have chosen the Freeze/Float options in the fourth allotment list (Published on 05<sup>th</sup> June, 2023) and they are hereby directed to pay**

the above mentioned University fee from 05<sup>th</sup> June, 2023 to 10<sup>th</sup> June, 2023 upto 10:30 p.m. through following ICICI Bank Payment Gateway :

failing which their claim of admission in Academic Year 2023-24 would be forfeited.

**Note :**

- (1) Those candidates who have chosen the option of Freeze for CNLU, Patna in First, Second and Third Allotment list and have already paid University fee at Chanakya National Law University (CNLU), Patna shall not pay again.
- (2) Those candidates who have chosen the option of float in third allotment list and paid University fees of CNLU, Patna and still their name is in CNLU in the fourth allotment list shall not pay the University fee again.
- (3) Those candidates who have chosen the option of float in third allotment list and paid University fees to CNLU, Patna and they have moved to other National Law Universities in the fourth allotment list, their deposited fees at CNLU, Patna will be transferred to the concerned University in due course of time.
- (4) Those candidates who have chosen the option of float in third allotment list and paid University fees to their concerned National Law University and they have moved to CNLU, Patna in the fourth allotment list are hereby directed **not to pay** University fees at CNLU, Patna because their deposited fee from the concerned National Law University will be transferred to CNLU, Patna in due course of time.

Candidates shall have to **upload** the **scan copies** of following documents as given below on CLAT Consortium Portal, 2023 **only** within the **stipulated time as given by the Consortium of National Law Universities, Bengaluru**. Those students who have already **uploaded scan copies of the following documents at Consortium Portal need not upload again :-**

1. Transfer / Migration Certificate\*
2. Character/Conduct Certificate from the institution last attended indicating that he/she has never been found guilty of misconduct during the study period;\*
3. Original Matriculation Certificate or Mark-Sheet where Date of Birth is clearly mentioned for verification of Date of Birth;
4. Marks Sheet of Matriculation/10<sup>th</sup>;

5. Marks Sheet of Intermediate / 10+2. Candidates who have passed 10+2 examination of 2023 would upload certificate/web copy on the consortium portal.
6. Caste Certificate issued by competent authority of Govt. of Bihar (*Applicable for the reserved category candidates only*), if applied and allotted under the reserved category.
7. Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2022-23) (*Applicable for the EWS category candidates only*), if applied and allotted under the reserved category.
8. Admit Card of CLAT-2023.
9. PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.

**At the time of admission (date will be notified in the third week of June, 2023) all admitted students shall have to bring original copies of all the above-mentioned documents along with one set photo copies, failing which their admission will stand cancelled.**
