1. 2. Application Fee : NIL
3. Tuition Fee : NIL
4. Candidate can avail admission in only one batch at Career Guidance Centre, CNLU, Patna. The admitted student will not take further admission in any next batches for the same course.
5. Batch will consist of 60 students for both BC & EBC category students.
6. 40% i.e. 24 seats will be reserved for the students of Backward Classes (BC).
7. 60% i.e. 36 seats will be reserved for the students of Extremely Backward Classes (EBC).
8. 33% horizontal reservation for women in each category is admissible. All reservation policy will be implemented as per Bihar Govt. Reservation Act in admission.
9. Original copy of Income Certificate of financial Year 2022-23 of not more than Rs. 3,00,000/- (Three Lakh) per annum of student including the income of Parents/Guardians. Income Certificate shall be issued by the competent authority of Bihar.
10. BC and EBC Categories Certificate must be issued by the competent authority of Govt. of Bihar.
11. The selection will be made on the basis of rank obtained in the written examination of 100 marks and 25 marks will be the passing marks for the written examination for admission. Students who will get less than 25 marks in the qualifying examination will be not be considered for admission. For admission their rank and seats available in the caste category will be considered only.
12. **The students who will apply must have passed in Intermediate Examination.**
13. ***Classes will be held in English language.***
14. Any concealment of required information or furnishing of wrong information will amount to cancellation of admission at anytime.
15. The Career Guidance Centre, CNLU reserves the right to cancel the admission of any candidate who indulges in any act of indiscipline or is guilty of misconduct during the course of study at Career Guidance Centre, CNLU, Patna, (Bihar).
16. No Hostel/Mess/Library facility of Chanakya National Law University, Patna will be available to the admitted students.
17. The admitted students shall be in the CNLU campus only for their classes purpose. Before and after the class they shall not roam around the campus for any purpose. The competent authority will take appropriate action in this regard.

**Instructions for Document Verification at the time of Admission**

**At the time of admission bring your all the following essential documents for physical verification :**

1. Original and Self attested copy of Matriculation Certificate & Marks Sheet where Date of Birth is clearly mentioned for the verification of Date of Birth.
2. Original and self attested copy of Intermediate Certificate & Marks-Sheet.
3. Original and self attested copy of Aadhar Card.
4. Original copy of Income Certificate of not more than Rs. 3,00,000/- (Three Lakh) per annum of student including the income of Parents/Guardians. Income Certificate shall be issued by the competent authority of Bihar.
5. Character/Conduct Certificate from the institution last attended indicating that he/she has never been found guilty of misconduct during the study period.
6. The candidate must be a permanent resident of Bihar.
7. Original Caste Certificate of BC/EBC issued by competent authority of Govt. of Bihar.
8. Original and Self attested copy of Permanent Residential Certificate issued by the competent authority of Govt. of Bihar.
9. PWD Certificate, if any candidate under PWD Category of BC/EBC Category.
