## Competition Guidelines

The competition is the ultimate drafting test. Each team must submit a *Memorandum* to the Client providing their legal opinion on the issues instructed by the Client ("Memo") and the *Draft Contract* ("Contract") on a hypothetical case provided to them.

#### Mode

The competition shall be conducted in **virtual** mode.

#### **Team Composition**

Each team shall comprise of minimum **one** and maximum **two** participants.

#### **Registration Fee**

- The registration fee for the competition is INR 500/- (Single participant).
- The registration fee for the competition is INR 700/- (Dual participation).

#### **Evaluation Criteria**

Submissions will be judged on the following parameters:

- Language of the contract and type of drafting;
- Advice to the Client's queries and demands;
- Formatting of the contract;
- Application of laws.

#### **Submission Guidelines**

- Each team shall submit a Memorandum to the Client providing their legal opinion on the issues instructed by the Client ("Memo") and the Draft Contract ("Contract") on the hypothetical case provided to them in a single document.
- Submissions shall be made in .doc or .docx format only.
- The "contract" and the "memo" shall be drafted in English language only.

## Competition Guidelines

- The "memo" shall be drafted on the basis of the "Client Instructions" and shall not exceed two (2) A4-sized typewritten pages. Five (5) marks shall be deducted as penalty for each page exceeding the page limit.
- The "contract" shall be drafted on the basis of the "Problem Statement". The contract shall not exceed more than five (5) A4-sized typewritten pages. Five (5) marks shall be deducted as penalty for each page exceeding the page limit.
- The document containing the "contract" and the "memo" shall not reveal the identity of the participants, in any manner whatsoever.
- Soliciting assistance from industry professionals with or without consideration is strictly prohibited.
- Formatting: Font style Times New Roman, font size 12, line spacing 1.5, justified alignment, paragraph spacing – 0 pt before and after, 1 inch margin on all sides.
- Submissions shall be made by sending an email to carcil@cnlu.ac.in with the subject "Submission for contract drafting competition: [Team Code]".
- Clarifications on the Problem Statement shall be sent to carcil@cnlu.ac.in with the subject.

#### Awards
