

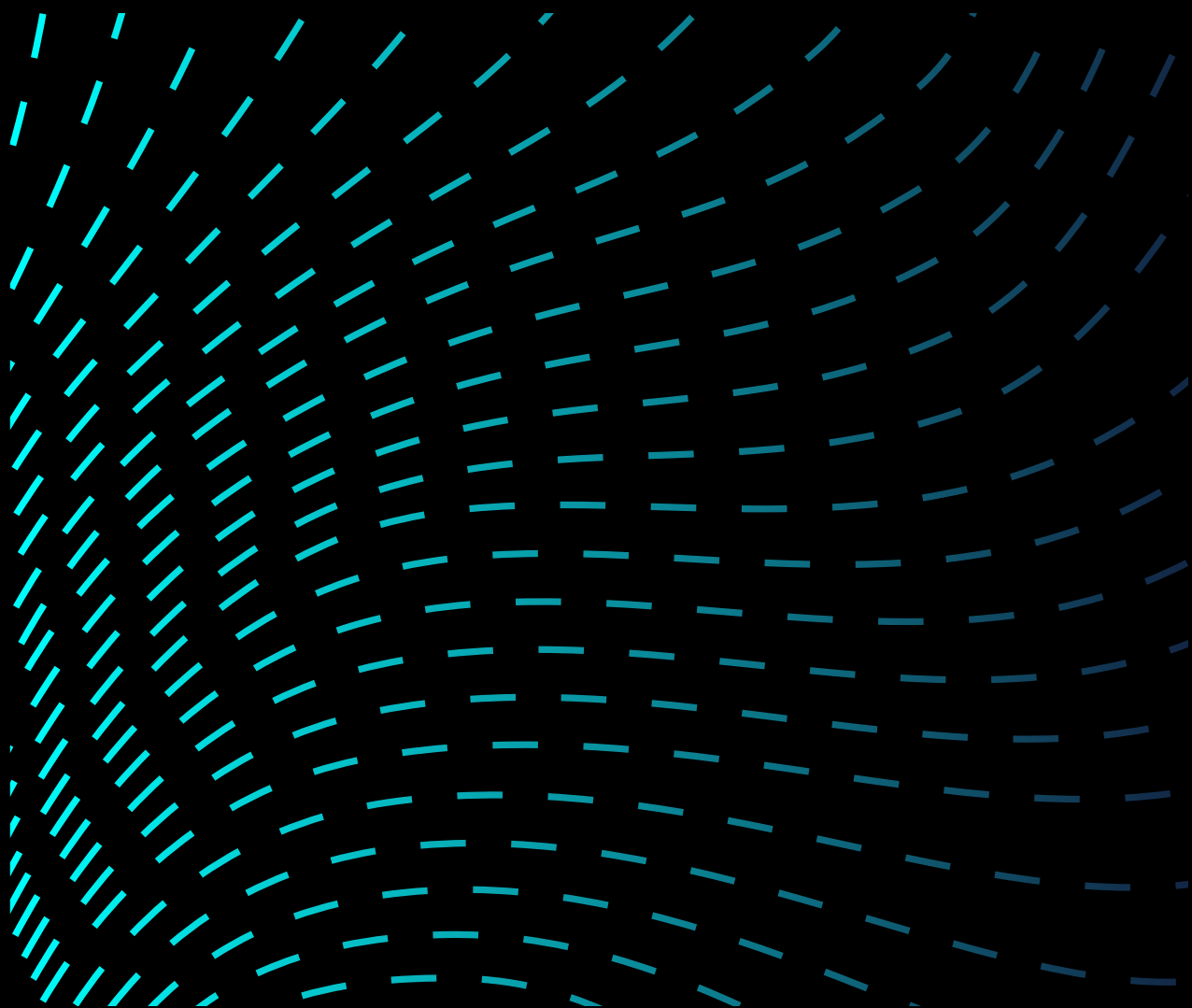


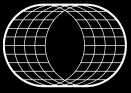

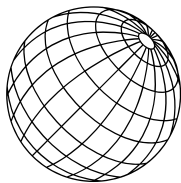
ABOUT CARCIL

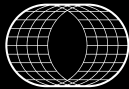
ABOUT THE COMPETITION

RULES - AND - REGULATIONS

MODE

THE COMPETITION SHALL BE CONDUCTED IN ONLINE MODE FROM 6TH OCTOBER, 2023 TO 9TH OCTOBER, 2023.

TEAM COMPOSITION

EACH TEAM SHALL COMPRISE OF MINIMUM ONE AND A MAXIMUM OF **THREE** PARTICIPANTS.

ELIGIBILITY

THE COMPETITION IS OPEN TO BOTH UNDERGRADUATE AND POSTGRADUATE STUDENTS CURRENTLY ENROLLED IN ANY RECOGNIZED COLLEGE OR UNIVERSITY. PARTICIPANTS MUST MAINTAIN THEIR STATUS AS STUDENTS OF THAT COLLEGE OR UNIVERSITY THROUGHOUT THE DURATION OF THE COMPETITION.

ROUNDS

THE COMPETITION WILL BE CONDUCTED IN THREE PHASES IN VIRTUAL MODE, THE FIRST PHASE WILL BE A **SCREENING ROUND**, THE SECOND WILL BE THE **PRELIMINARY ROUND**, AND THE LAST WILL BE THE **FINAL ROUND**.

ROUND ONE SCREENING ROUND

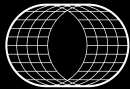
TEAMS WILL BE EVALUATED AND SHORTLISTED BASED ON THE BUSINESS PLAN SUBMITTED BY THEM. THE DOCUMENT SHOULD NOT EXCEED 15 PAGES (ADDITIONAL 05 PAGES CAN BE ATTACHED AS SUPPORTIVE DOCUMENTS). THE SUBMISSION SHOULD BE DONE IN PDF FORMATS.

ROUND TWO PRELIMINARY ROUND

THE TEAMS WOULD BE GIVEN 8 MINUTES TO PRESENT THEIR IDEA IN BRIEF WHICH WOULD BE FOLLOWED BY A Q&A SESSION WHICH WOULD LAST FOR 3-5 MINUTES.

ROUND THREE FINAL ROUND

THE TEAMS WILL BE GIVEN 15 MINUTES TO PRESENT THEIR IDEAS, FOLLOWED BY A 6-8 MINS Q&A SESSION.

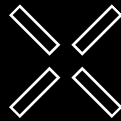


COMPETITION TIMELINE



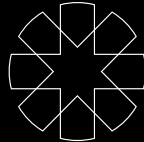

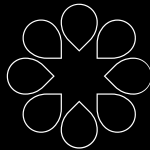

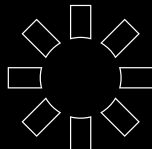

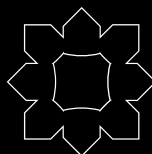
