SUBMISSION GUIDELINES

- The blog posts can be in the form of case comments, legislative review, discussion on contemporary issues, short article, etc.
- Submissions should preferably be within 1000 1500 words excluding footnotes.
- All submissions must be accompanied by an ABSTRACT of not more than 200 words and 5 (five) keywords.
- Main text: Times New Roman, font size 12, 1.5 spacing, justified alignment, with a margin of one inch on all sides
- **Footnotes:** Times New Roman, font size 10. Substantive foot notes are accepted. Speaking footnotes should be avoided.
- Citation style: ILI citation style.
- The manuscript shall be original and unpublished
- Permissible plagiarism limit is 10%., the submissions shall be peer reviewed.
- Submissions must be in MS Word (.doc or docx.) format only. Submissions made in any other format shall not be considered.
- Authors must indicate their academic qualifications and the name of the university/institution to which they are affiliated.
