PROBLEM STATEMENT



PRELIMINARY ROUND - 1

Dr Rishabh Verma is the founder of TechMed Innovations. Rishabh, an accomplished biochemist, started the company to revolutionize healthcare in India with affordable, efficient, and high-quality diagnostic tools. With a vision to bring accessible healthcare closer to every Indian, especially in remote areas. Rishabh was the company's heart and soul.

Jayesh Patel met Rishabh at a healthcare tech event in Bali. Jayesh is a dynamic entrepreneur with expertise in marketing and business development. He has previously led several startups to success through his vast network in the healthcare industry. Passionate about the digitization of healthcare, Jayesh sees immense potential in India's healthcare sector.

In a fateful meeting at a tech-healthcare conference in Bali, the two visionaries, Rishabh and Jayesh, found mutual interests. Upon discussions about the inefficiencies in diabetes diagnostic methods in India and the unavailability of quality kits in rural areas, the duo decided to join forces.

Charmed by Rishabh's inventions that had already garnered attention and awards, Jayesh proposed a partnership. Rishabh, sensing an opportunity to amplify the reach of his products, agreed. Their partnership agreement, written on a hotel serviette, became a testament to their shared dreams, which was named as “Tech Med” and was later displayed in their Hyderabad office. He has now approached CCADR to request a consultation with expert lawyers who can guide him and apprise him of his available options, on 6th October 2023 at CNLU, Patna.

EVALUATION CRITERIA

Each Team will be judged by a panel of two judges for preliminary rounds and two/ three or more judges for the Semi-final and Final rounds. The teams shall have to conduct a consultation and a post-consultation round. In the post-consultation round, the teams shall also face questions from the judges. The client shall be provided for these purposes by the Organising Committee.

In order to preserve anonymity, each team will be identified by an Alpha- Numeric code, which will be provided to each team during registration process.

Each judge will evaluate for a maximum of 100 marks independently. The scores of all the judges for each team will be added and then listed according to the team scores (best team scoring highest points). The aggregate score of both the team members shall be considered.
