**PROBLEM STATEMENT**



## PRELIMINARY ROUND - 2

Hailing from the picturesque coastal town of Mangalore, Anjali Rao, a dynamic 28-year-old, emerged as a sensation among health-conscious food enthusiasts. The serene backdrop of the Netravati River mirrored the pure and wholesome recipes Anjali brought to her fans. On SnapTaste, a trending social media platform, Anjali's profile gleamed with a commendable 70k followers. Since 2017, her channel has been a treasure trove of videos, focusing primarily on paleo-friendly dishes, which captivated health warriors from every corner. The global pandemic served as a blessing in disguise for Anjali. Confined to their homes, people gravitated towards maintaining their health, and Anjali's sugar-free treats became a sought-after solace.

However, the surge in demand soon exceeded Anjali's in-house capabilities, and tragedy struck on September 5th, 2023, when Anjali logged onto SnapTaste only to find a flood of negative feedback and a shocking decrease in followers that jolted her. The culprit was a large order of 800 Pastries crafted for customers adhering to a paleo diet. Instead of using Stevia, Refined Sugar was mistakenly incorporated, causing dietary distress for her clientele. The aftermath? A staggering compensation demand of 120,000 INR from the consumers, a significant drop in customer trust, and a tarnished online reputation.

Seeking help and guidance, Anjali approached legal experts through CCADR for a consultation to be done on 6th October 2023 at CNLU, Patna. While Anjali was convinced that the blunder wasn't intentional and that the oversight, albeit grave, was an honest mistake - the need of the hour is to find a solution that would result in a peaceful resolution, and to also apprise Anjali of the possible repercussions.

# EVALUATION CRITERIA

Each Team will be judged by a panel of two judges for preliminary rounds and two/ three or more judges for the Semi-final and Final rounds. The teams shall have to conduct a consultation and a post-consultation round. In the post-consultation round, the teams shall also face questions from the judges. The client shall be provided for these purposes by the Organising Committee.

In order to preserve anonymity, each team will be identified by an Alpha- Numeric code, which will be provided to each team during registration process.

Each judge will evaluate for a maximum of 100 marks independently. The scores of all the judges for each team will be added and then listed according to the team scores (best team scoring highest points). The aggregate score of both the team members shall be considered.
