1. **M/s Nutech office System (P) Ltd. :-**
Technical evaluation committee examined papers uploaded by Nutech office System (P) Ltd. And found it responsive in technical bid.
2. **M/s Vishala Industrial Craft (P) Ltd.:**
Technical evaluation committee examined papers uploaded by Vishala Industrial Craft (P) Ltd. And found it non- responsive in technical bid due to following reasons:
 - I. ATO of Vishala Industrial Craft (P) Ltd. was not uploaded.
 - II. IT Returns of Vishala Industrial Craft (P) Ltd. was not uploaded.

3. Bonton Technomake Pvt. Ltd. :-

Technical evaluation committee examined papers uploaded by Bonton Technomake Pvt. Ltd. And found it responsive in technical bid.

Recommendations of Technical Bid Evaluation Committee:

After thorough discussion, the Technical Bid Evaluation Committee held on 13.09.2023 unanimously, out of three tenderer two tenderers, namely; **a)** Nutech Office Systems (P) Ltd. and **b)** Bonton Technomake Pvt. Ltd were found responsive and so successful in the technical bid evaluation. It was recommended to put it on CNLU website and objection/complaint if any, was to be received latest by 16.09.2023 (Saturday).

One objection has been received on 15.09.2023 from M/s Vishala Industrial Craft (P) Ltd.

Objection raised	Reason for Disqualification
Tender NIQ eligibility/ Checklist criteria no. 6, where clause was written vague, the clause doesn't mention that if you are an Authorized dealer you have to submit the ATO and ITR of yourself along with the OEM documents. We have participated as an authorized dealer and we have enclosed the ATO and ITR of the OEM.	<p>Checklist in clause no. 6 states : "The firm must have average annual turnover of Rs. 5.00 crore per annum during the last 3 financial years. i.e. FY 2020-21, 2021-22 & 2022-23. Documents in support of turnover (along with Income Tax Returns, Profit & Loss Statement, Balance Sheet and Audit Report/Tax Audit Report of the relevant years) must be uploaded with the tender"</p> <p>By the above mentioned clause no. 6, it is clear that the firm participating in the tender must upload the ATO and ITR. The Tenderer i.e. M/s Vishala Industrial Craft (P) Ltd. have already uploaded GST and PAN but have not uploaded ATO and ITR.</p> <p>After thorough discussion, the Technical Bid Evaluation Committee unanimously rejected objection raised.</p>

Proceeding of the Technical Bid Evaluation Committee should be put up on CNLU website. The meeting concluded with vote of thanks.
