GENERAL GUIDELINES

1. There will be two rounds in the competition, Preliminary and Final Rounds.
2. Preliminary Round will be done through Google Form and Final Round will be done through Zoom.
3. The final round consist of objective question round and rapid fire round.
4. The decision of the quiz-master will be final and will not be subjected to any change.
5. Questions will be asked from the area of Legal Services Authorities Act, 1987, Public Interest Litigation, Right to Information Act, Human Rights, Consumer Protection Act, Rights of the Victim, Alternative Dispute Resolution.
6. Top 10 teams will proceed to the Final Round. Selection of the team will be decided based on total marks scored and the time clocked in the preliminary round.
7. The participants shall not be allowed to use mobile or other electronic instruments.
8. The questions shall be in the form of multiple choice, True/False statement etc.

TIME LIMIT

- 1. Preliminary Round:** There shall be total 50 MCQs, which need to be answered in the duration of 20 minutes.
- 2. Final Round:** The top 10 teams will proceed to the Final Round. Selection of the team will be decided based on total marks scored and the time clocked in the preliminary round.
