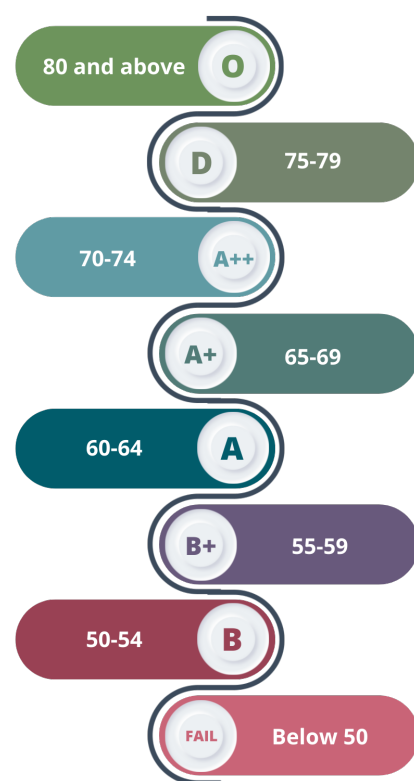
EVALUATION AND GRADING SYSTEM

The university conducts Mid-Semester and End-Semester examinations in each semester. Beside the semester examinations, the University also allows various relevant research project topics to the students in each semester to keep them updated and further, enhance the analytical and research skills of the students.

It is mandatory for all the students to attend classes, and also a student in each semester is required to maintain a minimum attendance of 75%, failing which they are not allowed to give End-Semester Examinations.

The Contribution of each component of the Course while deciding the Grade is always in accordance with the Scheme given below:

Grades are awarded to Students in each Subject on the basis of the Final Result in each Semester which is inclusive of Mid Semester score, End Semester Score, marks scored in Research Project, and Attendance. The Grades are awarded on the following basis:



RESEARCH CENTRE AND CELLS

CENTRE FOR INNOVATION RESEARCH AND FACILITATION IN INTELLECTUAL PROPERTY FOR HUMANITY DEVELOPMENT [CIRF-IPHD]

CENTRE FOR INNOVATION, INCUBATION AND LEGAL ENTREPRENEURSHIP (CIILE)

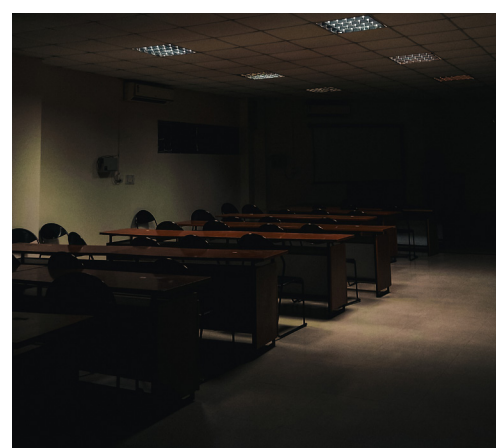

CHANAKYA LAW REVIEW

The Chanakya Law Review (CLR) is an International Journal (E-Journal) of Fundamental Research and Development in the field of Law interface with other Social sciences and Humanities interface with law. It is a Half-yearly Research Journal which aims to encourage authors to write papers on international issues involving multidisciplinary fundamental research and disseminate knowledge worldwide. Its objective is to provide contemporary insight and add value to the existing Indian legal framework. CLR till date has issued Three Volumes (Issue 1) in furtherance of its objective.

The Vice-Chancellor, CNLU, Patna is the Patron, and The Director of the Centre is the Chief Editor of the Journal.

IP BULLETIN

The Intellectual Property Bulletin is a publication of the Centre for Innovation Research and Facilitation in Intellectual Property for Humanity and Development (CIRF-in- IPHD). This centre is another venture with respect to the National IPR Policy 2016 and strives to work as per CIPAM and MSME. It is a half-yearly Magazine which carries news, column, case reports, essay writings, events and activities, and research in the domain of Intellectual Property Rights.

CNLU NEWSLETTER

CNLU with the aim to promote Creativity, Innovation in Legal Professional Education, publishes its half-yearly newsletter which comprises all the events, conferences and other allied events. It basically includes and recognizes the activities done under the aegis of college administration by different committees, faculty members and college students. The most recent newsletter published under Patron-in-Chief of Vice Chancellor is Volume 3 Issue.1[January 2022-June2022], which exhibits not only college news but also portrays achievements of Faculty members, students etc.

MOOT COURT COMMITTEE



The Moot Court Committee (MCC) facilitates moot court activities along with client counselling, witness questioning, and cross-examination through simulated trials, both at National and International level, which advances various skills like drafting, oral argument, etc. Furthermore, by organising two Intra-Moot Court Competitions, the committee aims to encourage students to apply their skills to nuanced areas, depicted through an innovative moot scenario.

CHILD RIGHTS CENTRE



The Child Rights Centre is proposed to be a specialized research centre of the Chanakya National Law University to be run in assistance with UNICEF. The Centre's mission is to engage with child rights from a multidisciplinary perspective and to provide integrated technical support to different layers of institutional governance at the local, state and national levels for the protection of child rights through Knowledge Management, Human Resource Development and System Strengthening.

LEGAL AID CELL



The Cell strives to ensure fair and meaningful justice for the marginalized and disadvantaged by bringing them legal awareness and aid. The cell tends to improve the lives of the impoverished and oppressed and raises awareness among them. Legal aid includes approaching top lawyers to take on pro bono cases for those who request assistance. The cell has worked in collaboration with NGOs like 'Bal Sakha', 'Aman', "Sehgal Foundation" etc, to provide pro bono legal aid. The cell had also held its inaugural National Legal Aid Fest, "Vidhikta" in which numerous renowned law schools and other colleges from all across India participated.

CULTURAL COMMITTEE



The Cultural Committee 'Avirbhaav' embodies the spirit of Bihar's culture, which is one of the country's key heritage centres and the birthplace of Lord Buddha. Apart from encouraging students to participate in cultural events, the Committee organises the University's Annual Fest "Jeevatva", which provides a platform for the student community to nurture and showcase their talents in the fields of dramatics, music, and art etc.

It publishes articles written by practitioners, legal experts, and students on topics of relevance to the legal profession and academia.

The Sports Committee provides training to students who represent the University at national levels. EVENTS ORGANISED

1ST CNLU-CCI NATIONAL MOOT COURT COMPETITION 2022 (11-13 MARCH, 2022)

In order to stir up research on issues in competition law, CNLU organised the 1st Edition of the CNLU-CCI National Moot Court Competition 2022, supported by the Competition Commission of India and in association with Lakshmikumaran and Sridharan Attorneys, from 11th to 13th March, 2022. The rounds were held in the virtual mode and it saw the participation of students from India's leading law schools and of judges from India's top law firms.

13TH CNLU NATIONAL PARLIAMENTARY DEBATE COMPETITION 2022 (23-25 SEPTEMBER, 2022)

For inculcating and promoting healthy and competitive debating, CNLU organised its most anticipated flagship event, the 13th Edition of its National Parliamentary Debate Competition, from 23rd to 25th September, 2022. The rounds were held in the offline mode in the CNLU campus and saw the participation of debaters and adjudicators from all across the country. The tournament was held in the Asian Parliamentary Debate format.

CAPACITY BUILDING PROGRAMME ON CORPORATE AND INSOLVENCY LAWS 2022 (26-30 JANUARY, 2022)

CNLU under the aegis of Centre for Advanced Research in Corporate and Insolvency Laws

(CARCIL), with the objective to introduce the areas of current corporate laws and insolvency and bankruptcy law regime in India, organised a 5 days Capacity Building Programme on New Space of Corporate and Insolvency Laws from 26th to 30th January, 2022. The programme was for law faculties with a blend of eminent expert speakers from top institutions and top law firms of the country.

1ST CNLU NATIONAL MEDIATION COMPETITION 2023 (21-22 January & 11 February, 2023)

The Chanakya Centre for Alternative Dispute Resolution in association with India's leading law firms, PSL Advocates & Solicitors and Singhania & Partners LLP organised its first national mediation competition in hybrid format. The proposition was based on contractual laws, commercial laws and family law, having the participation from leading law school in India. The competition aligns with the goal of CNLU to foster an environment for academic research and the development of ADR culture among the students.

2ND CNLU CYBER LAW NATIONAL MOOT COURT COMPETITION (6-7 & 27 JANUARY, 2023)

To encourage the participants to indulge in in-depth knowledge of the emerging trend of cyber space, Chanakya National Law university in association with Scriboard organized its Second Edition of Cyber Law National Moot Court Competition in hybrid format in the month of January, 2023. Efforts were made to ensure that the participants are provided with realistic impression of Cyber law.

1ST CARCIL BOARD SIMULATION COMPETITION 2022 (15 SEPTEMBER, 2022)

CARCIL with the aim to promote skills in interpreting and applying business concepts and taking critical decisions for a company, organised the 1st Board Simulation Competition 2022 on 15th September, 2022. Participants enacted board meeting of hypothetical companies complying with Secretarial Standards and relevant rules.

GUEST LECTURE ON 'DELAY CLAIMS IN CONSTRUCTION ARBITRATION- PRACTITIONER'S INSIGHT ON CASE PLANNING AND STRATEGY' (26 AUGUST, 2022)

CONTACTING THE RECRUITER FOR THE FIRST TIME

Recruiters will get invitations from the CDRC, along with a placement brochure and other pertinent information. An organisation may also email a summary of possible employment opportunities to cdrc@cnlu.ac.in.

PRE-PLACEMENT CONSULTATIONS

We urge recruiters to meet with prospective applicants for Pre-Placement Discussions. It will allow students to discover more about the recruiter, including its vision and mission, career opportunities, and work culture, among other factors. However, the discretion of the recruiter shall be final in this case.

02

INTERVIEW SCREENING PROCESS

An Interview Screening Process may be undertaken before the final interview if the recruiter feels it necessary. Group discussions, telephonic or skype interviews, written assessments, and any other process that the recruiter deems appropriate may all be part of the process.

03

INTERVIEW

The recruiter must present a candidate list to the CDRC after completing the Interview Screening Process. If an applicant is unable to attend the interview, the recruiter may create a waitlist of students who may be interviewed.

04

RECRUITMENT PROCESS

To streamline the recruitment process, the CDC has created the following rules for the recruiter as well as students:

INTIMATION OF OFFERS

The recruiter is expected to notify the Placement Cell of any offers made to the students. A waitlist may be published along with final offers if the recruiter feels it suitable.
