General Conditions:

- 1. The prescribed qualifications and experience are minimum and the mere fact that an applicant possesses the same will not entitle him / her for being called for interview. The University reserves the right to restrict the applicants to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit. Those who are possessing higher qualifications will be given preference. The University may constitute a Screening Committee to scrutinize the applications and short-list the applicants. Call letter for interview will be sent only to the short-listed applicants and no correspondence will be entertained with applicants who are not short-listed.
- **2.** Applicants applying for more than one academic position should apply in separate application form for each position along with the fees prescribed.
- **3.** Applicants who wish to apply against the specialised posts have to submit separate application forms for each post along with the fees prescribed as shortlisting would be done separately for each post.
- 4. The University on the recommendation of the Selection Committee may offer a lower post to an applicant who may have applied for a higher post depending on his/her performance in the Selection Committee for the advertised posts.
- 5. Applications incomplete in any respect shall not be considered at all.
- 6. The University reserves the right to fill all the positions advertised or fill-up some of the positions or not to fill any of the positions.
- 7. The University may offer contractual positions in place of regular positions either on UGC Pay Scales or on consolidated salary.
- 8. University will make all correspondence only through email.
- 9. In case of any disputes / suits or legal proceedings against the University, the Jurisdiction shall be restricted to the High Court of Judicature at Patna.
- 10. EWS/BC/EBC/SC/ST applicants from States other than Bihar shall be treated as Unreserved Applicants.
- 11. The University is providing transgender reservation under Backward classes (BC) category

serial No. 47 as notified by General Administrative Department, Govt. of Bihar, dated 12.09.2014.

- 12. The reservation roaster as prescribed by Govt. of Bihar shall be followed.
- 13. Letter No. 11/आ॰नी॰-I-11/2015 सा॰ प्र॰ 2342, dated 15.02.2016 of General Administration Department, Govt. of Bihar would be applicable in the reservation policy.
- **14.** PWD reservation will be followed as the notification issued by the Ministry of Social Justice and Empowerment, New Delhi.
- 15. The applicant must be a citizen of India. Non-citizens may be given contractual positions.
- **16.** Preference will be given to the applicants who have the experience of teaching in National Law Universities.
- 17. The age of superannuation would be 65 years for Assistant Professor, Associate Professor and Professor.
- **18.** The number of vacancy may vary.
- **19.** Interested applicants are required to submit application forms through offline mode along with all relevant attachments through registered post / by hand:

- 20. Last date for submission of the duly filled-in application forms for the first round of selection committees is Saturday, the 25th November, 2023 till 05:00 p.m. For subsequent rounds of selections, applications received two weeks prior to interviews would be considered.
- 21. The envelope must be superscribed with the words "Application for the post of Professor/Associate Professor/Assistant Professor) and Advertisement Number.
- 22. Applicants shall have to produce original documents at the time of interview.
- **23.** Canvassing in any form/bringing in any influence political or otherwise will be treated as a disqualification for the Post.
- **24.** The shortlisted applicants will be intimated through email.
- **25.** No TA/DA will be paid for appearing in the interview.
