This includes –Admission fee, Facilitation fee, Library fee, Library deposit fee, Retention fee and Course work fee, etc for the session 2023-24.
- The Candidates who are employed must bring NOC from their respective employer that he/she has been granted leave for Ph.D. Course work (Minimum six months to one year), failing which the candidate shall not be allowed admission. Such candidate shall forfeit their opportunity. No further request shall be entertained in this regards.


