- role of technological innovation in combating climate change and promoting sustainable development is also explored.

4. Climate Change and Human Rights

• impact of climate change on marginalized communities, women, children, indigenous peoples, and developing nations.

- importance of a human rights-based approach to address climate change and protect vulnerable populations.
- 5. The Legal and Regulatory Framework for Climate Change in India
 - India's legal and regulatory framework for climate change, focusing on the National Action Plan on Climate Change (NAPCC) and relevant environmental laws.
