1. IMPORTANT EVENTS

(a) <u>13th CNLU PARLIAMENTARY DEBATE</u>:

The Academic and Debating Committee of the University has organised the 13th Parliamentary Debate competition from 23rd to 25th September, 2022. A total of 24 Teams from reputed Institutions across the nation have participated in this competition. Ms. Angela Elsa John, Ms. Anjali Gurumurti and Mr. K. K. Prahlad of DSNLU, Visakhapatnam was adjudged as winners of the competition and Ms. Elsa Sibu, Ms. Arthi and Ms. Eshita Milinda of DSNLU, Visakhapatnam was adjudged as runner-up of the competition. Ms. Ankita, Ms. Harsha and Ms. Swati of CNLU were declared novice winners. Ms. Elsa Sibu of DSNLU, Visakhapatnam was adjudged as Best Speaker.

Hon'ble Mr. Justice Navin Sinha, (Retd.) Supreme Court of India was the Chief Guest of the event and Hon'ble Mr. Justice Dr. Anshuman, Patna High Court was the Guest of Honour.

(b) 2nd EDITION OF CNLU CYBER MOOT COURT COMPETITION:

The University organised 2nd Edition of Cyber Moot court Competition in hybrid mode. The preliminary and quarter finals were held in online mode on 7th-8th January, 2023. The Semi-final and Final were held in off line mode on 27th January, 2023. Hon'ble Mr. Justice Rajeev Ranjan Prasad, Judge, Patna High Court was the Chief Guest in the valedictory ceremony. NLU, Gujarat was judged winners of the competition and Institute of Law, Nirma University was adjudged as runner-up of the competition. Around 40 teams have participated in the competition from the Institutes/Universities of national repute.

(c) 1ST EDITION OF CNLU NATIONAL MEDIATION COMPETITION:

The University has organised the 1st edition of National Mediation Competition in collaboration with Associates partners – Singhania & Partners LLP and PSL – Advocates and Solicitors Knowledge partners International Arbitration and Mediation Centre, Hyderabad, ADR Hoc, YCM India, Mumbai Centre for International Arbitration and IDRC in hybrid mode. The preliminary and quarter final rounds were held in virtual mode on 21st – 22nd January, 2023. The semi-final and final was held in off line mode on 11th February, 2023. A total of 32 teams from various Institutions of national repute have participated in the competition. The final round of the competition was adjudicated by Hon'ble Mr. Justice Mohit Kumar Shah, Judge, Patna High Court and Hon'ble Mr. Justice Dr. Anshuman, Judge, Patna High Court. Hon'ble Mr. Justice Chakradhari Sharan Singh, Acting Chief Justice, Patna High Court and Chancellor of the University was the Chief Guest of the valedictory ceremony and Hon'ble Mr. Justice Dr. Anshuman, Judge, Patna High Court was the Guest of Honour.

MNLU, Mumbai was adjudged as winner of the competition and Jindal Global Law School were adjudged as runner-up of the competition.

(d) CNLU-CCI NATIONAL MOOT COURT COMPETITION:

The Centre for Advanced Research in Corporate and Insolvency Laws of the University has organised the 1st edition of CNLU-CCI National Moot Court Competition in collaboration with Competition Commission of India and in association with Lakshmi Kumaran and Sridharan Attorneys between 11th - 13th March, 2022 in a virtual format. Around 37 teams from various parts of India of reputed Institutions/Universities have participated in the competition. Symbiosis Law School, Pune was the winner of the competition and HNLU, Raipur was the Runner-up. Hon'ble Mr. Justice Ashok Bhushan, Chairperson, NCLAT was the Chief Guest of the Competition and Mr. Ved Prakash Mishra, Advisor Law and Head of Legal Division, CCI was the Guest of Honour of the Competition in the valedictory session.

(e) NAAC ACCREDITATION:

The University was accredited with B Grade by the Executive Committee of the National Assessment and Accreditation Council. The University being not satisfied with the findings and the Grade point is in the process of applying for review of its Grade on completion of one year period.

(f) (i) ADMISSIONS TO B.A., LL.B. (HONS.) & B.B.A., LL.B. (HONS.):

In the academic year 2022-23, 80 students were admitted to the seventeenth Batch of B.A., LL.B. (Hons.) and 58 students were admitted to the tenth batch of B.B.A., LL.B. (Hons.) course on the basis of their ranks in CLAT-2022 which was conducted by the HNLU, Raipur. The Rules of Reservation as per Bihar (in Admission in Educational Institutions) Reservation Act, 2003 (Bihar Act No. 16 of 2003) were strictly followed for admissions.

(ii) LL.M. Programmes:

The University is offering specialisation in the branches of Corporate and Commercial Laws, Constitutional Law, Intellectual Property Rights, International Law, Criminal Law and Human Rights Law. The University has conducted Entrance Test for admissions to the fourth batch of one year LL.M. programme for the academic session 2022-2023 in the month of June, 2022. 66 students have taken admission. The University will conduct Entrance Test for LL.M. course for the academic Session 2023-2024 on 21st May, 2023.

(iii) LL.D./Ph.D./D.Phil - General Programmes:

The University has conducted the entrance examination for admission into LL.D./Ph.D. in Law and D.Phil. courses on 08th January, 2023 and 10 students have got admission on merit. During the academic session 2022-23 the University has awarded three Ph.D. degree and one LL.D. degree.

(iv) ADMISSIONS:

CNLU will admit 18th batch of B.A., LL.B. (Hons.) students and eleventh batch of B.B.A., LL.B. (Hons.) students on the basis of Entrance Examination through Common Law Admission Test (CLAT) CLAT-2023 conducted by the NLSIU, Bengaluru on 18th December, 2022.

The thirteenth batch of 5 year B.A., LL.B. (Hons.) and sixth batch of B.B.A., LL.B. Courses from CNLU is set to pass out in the month of May, 2023.

(v) DISPENSARY:

The University Medical Unit and Dispensary are providing medical facilities at three centres viz. Academic Block, Hall of Residence (Girls') and in the dispensary situated in Teacher's quarter to the satisfaction of students, staff and guests.

(g) MEETINGS OF UNIVERSITY AUTHORITIES:

The policy and decision making body *viz*. the Executive Council met 04 (four) times to decide the administrative and academic matters and to chalk out the policies to be implemented and to approve the recommendations made by other bodies. The Academic Council has met once to guide and transact the academic agenda and other academic matters including the award of various degrees and medals at the ensuing Convocation.

13. FACILITIES PROVIDED BY THE UNIVERSITY:

All student activities both curricular, extra-curricular and co-curricular activities like organization and participation of students in Moot Court Competitions, Model United Nations, Debate Competitions, Games, Sports, cultural and other activities at International, National, Regional and local levels are well encouraged and are fully financed by the University. 1 Gbps Pipeline has been provided under NKN-NMEICT Project, Govt. of India. Through which, Internet bandwidth of approx. 80 Mbps has been provided. Equipment installed in server room has power backup through Microtek 10 KVA Online UPS. Wi-Fi facility is available in Halls of Residence for Boys & Girls and in library. The University has also provided the facility of Gymnasium, Geyser and Water Cooler with RO facilities for the inmates of Halls of Residence of both Boys and Girls. University has placed CCTV Cameras all over the campus for better safety and security.

URKUND Plagiarism Software for Research degree has been provided by MHRD, Government of India through INFLIBNET. After denial of INFLIBNET authority for providing Plagiarism Software access for UG & PG degree, University has purchased annual subscription URKUND Plagiarism Software License for checking projects of UG and dissertation of PG. The University is providing Remote access of online E-resources to students and faculty members.

14. PLACEMENT AND PRE-RECRUITMENT CELL AND INTERNSHIP CELL:

Ms. Shweta Vats, Coordinator, Ms. Kirti, Ms. Nandita S. Jha, Prof. Ajay Kumar and Dr. B. R. N. Sarma are members of the Cell. University invited Law Firms and other recruitment officials for placements of University students. The object of the University *inter alia*, is to provide quality multi-disciplinary education in legal studies and to evolve and impart comprehensive legal education at all levels to achieve excellence. Accordingly, the University invited law professionals to impart professional skills besides helping students to find placements in the Corporate and other allied Sectors.

During the year 2022-23, 153 students selected in the Excise Department and 10 students got campus placements of the passing out batch 2017-22 got placement from reputed Law Firms and Bank and the placement of current batch of 2018-2023 is in process. Seven students of the current batch got campus placement by the reputed Law firms and Bank. The University has provided Mock Interview Training to the alumni of the University who have qualified the 31st Bihar Judicial Service Examination (Mains). Around 50 alumni of the University have been successfully appointed as Judges in the District Courts.

Further the Career Development and Internship Cell of the University is accommodating the students with regard to Internship opportunities for summer and winter placement regularly by approaching reputed Law Firms, Corporate Bodies and judiciary.

15. ADMINISTRATION OF THE UNIVERSITY:

The University administration including its Library and Halls of Residence consists of the supporting staff viz. Librarian, Finance Officer, Personal Secretary, Personal Assistant, Accounts Officer, Security officer, Resident Medical officer, Para Medical staff, Fire Fighting Supervisor, Office Assistants, Wardens, Assistant Warden, Library Staff, Data Entry Operators, Drivers, Attendants and other contractual and daily wages staff. The mess facility, cleanliness and gardening are outsourced. Most of the teaching and non-teaching staff are provided staff quarters. The University is constructing new residential quarters of Type-I, Type-II and Type-IV for both teaching and non-teaching additionally within the campus of the University funded by Department of Education, Govt. of Bihar.
