## NOTICE FOR ADMISSION TO FOREIGN NATIONALS AND NON-RESIDENT INDIANS (NRIs)

There are five seats for the Foreign Nationals and five seats for Non-Resident Indians (NRIs). Those candidates who wish to apply under these categories for B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) course in our University may apply directly to the University latest by 29<sup>th</sup> June, 2024 through the following Google Form link (*Sample of required data for Google Form and documents is enclosed*):

Candidates are hereby directed to pay Rs. 7,500/- (Seven Thousand Five Hundred only) as Application Fee which is non-refundable through the following ICICI Bank payment Gateway :

Please note that if Application Fee of Rs. 7,500/- (Seven Thousand Five Hundred only) is not paid on or before **29<sup>th</sup> June, 2024**, the candidature of candidate shall not be considered for admission. No further enquiry shall be entertained in this regard.

**For Foreign Nationals** merit shall be finalized on the basis of their percentage of marks in 10+2/ Intermediate or its equivalent. The Minimum percentage of marks in 10+2/ Intermediate or its equivalent for admission to B.A., LL.B. (Hons.) or B.B.A., LL.B. (Hons.) course will be 45%. In case of any grading system, the equivalent percentage shall be taken into consideration. However, candidate shall fulfil other eligibility criteria of CLAT-2024. In case of tie, preference shall be given to higher percentage of 10<sup>th</sup> marks. In case of further tie, preference shall be given to the one with higher age. Further tie, if any, shall be done by drawing a lot.

**The admission under NRI category** shall strictly be made on the basis of All India Rank (AIR) of CLAT-2024 which was organised by the Consortium of National Law Universities, Bangaluru on 03<sup>rd</sup> December, 2023. Candidates have to fulfil eligibility criteria and guidelines of CLAT-2024.

Applicants under Foreign Nationals/NRIs, if provisionally selected for admission for UG Course for the Academic Year 2024-25 shall complete the admission process by complying

with the notified norms of the University and paying required fees of Rs. 4,41,770/- (Four Lakhs Forty One Thousand Seven Hundred Seventy only).

**The provisional admission list will be tentatively published on 02<sup>nd</sup> July, 2024 on the University website i.e. <https://cnlu.ac.in/clat-2024/> and the admission process of the provisionally selected candidates shall be made in online mode till 04<sup>th</sup> July, 2024.**

**The classes for newly admitted UG students for the First Semester, Academic Year 2024-25 will commence from Monday, the 08th July, 2024.**
