

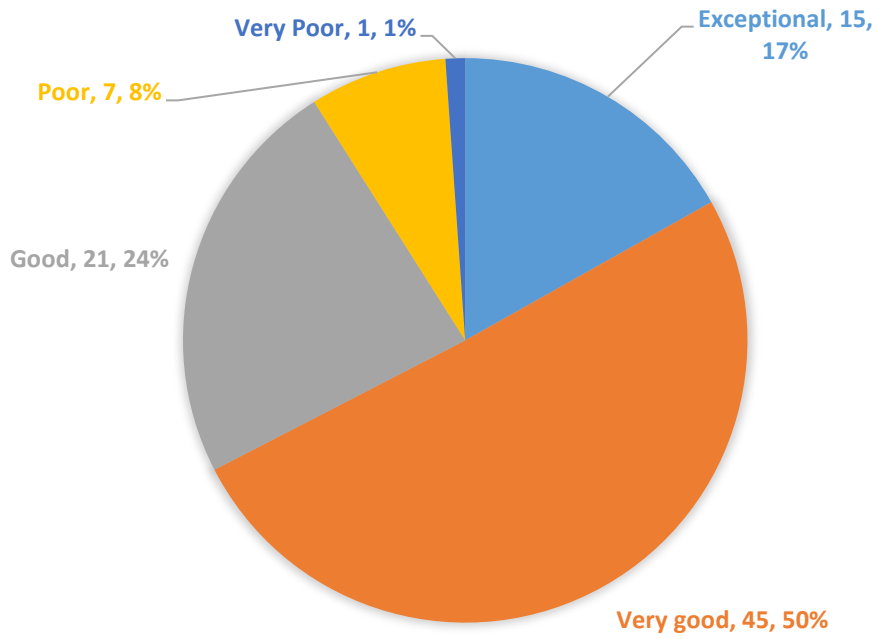

**Students' Feedback on Syllabus for the  
Academic Year 2022-23**

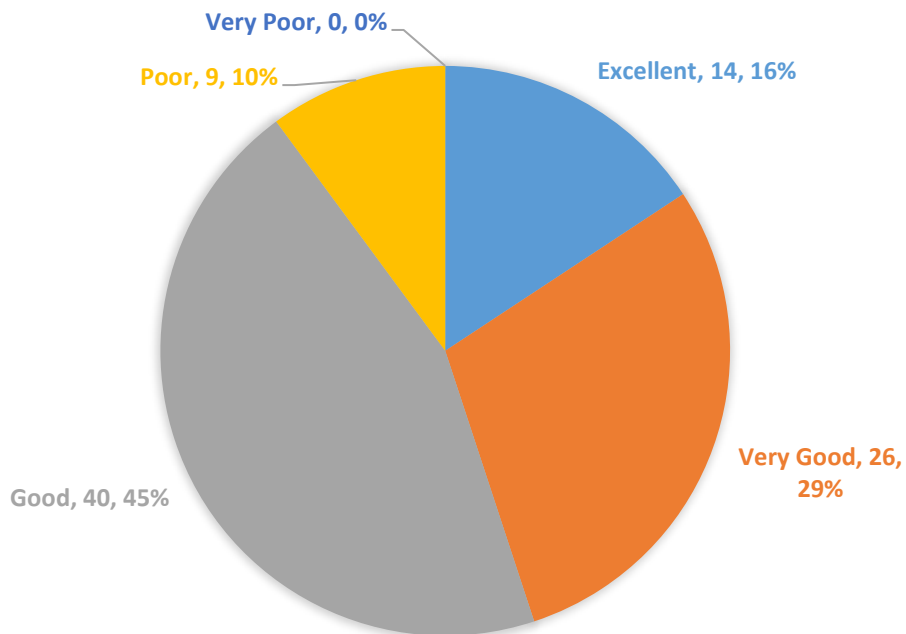
As part of the University's initiative of getting the feedback and opinion of various stakeholders on the syllabus of different courses offered by the University during the Academic Year 2022-23, Students' feedback was collected. The initiative aims *inter alia* at enriching the curriculum and enhancing the employability of its students. The feedback form comprised of eleven questions out of which nine questions were objective in nature and covered various aspects such as, relevance of the courses, achievement of the desired learning outcomes, overall quality of the syllabus, focus upon the employability and entrepreneurship skills, relevance of the curriculum for the local, national, regional and global developmental needs and integration of the crosscutting issues relevant to professional ethics, gender, human values, environment and sustainability into the curriculum. Two questions were open ended questions that aimed at eliciting suggestions by providing the students an opportunity to give suggestions for the review of the syllabus and inclusion of any other aspect in the feedback form.

A total of 89 students had filled up the feedback form. Their response was saved and analysed. Detailed report of the students' feedback is given below:

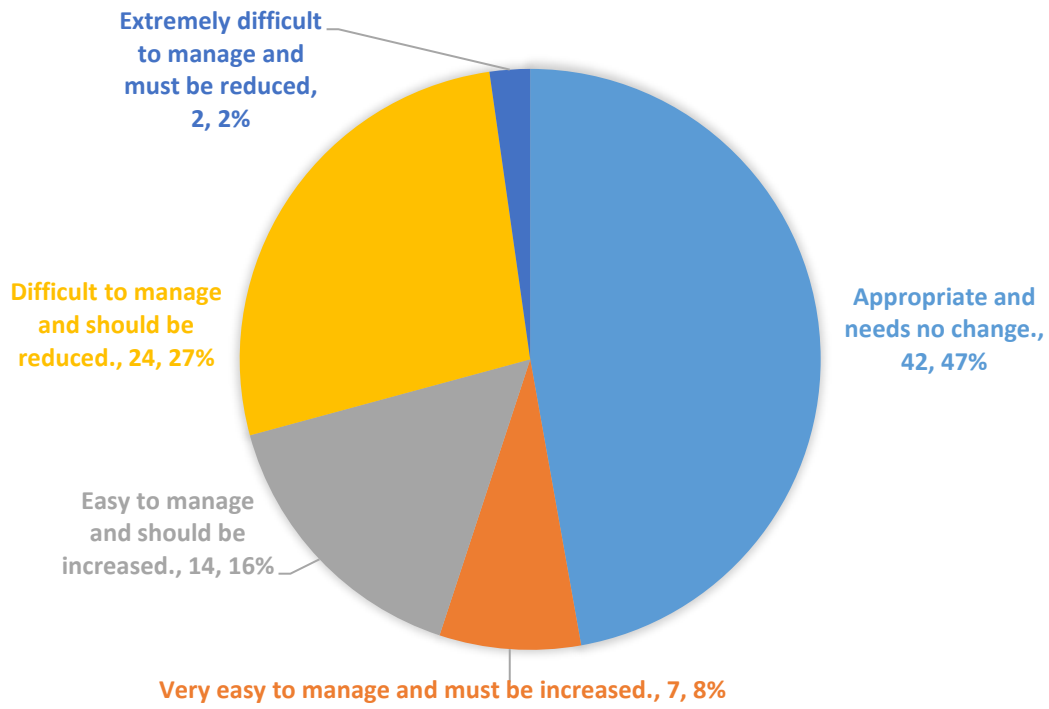
## RELEVANCE OF THE COURSES, FOR THE PROGRAMME YOU ARE PURSUING



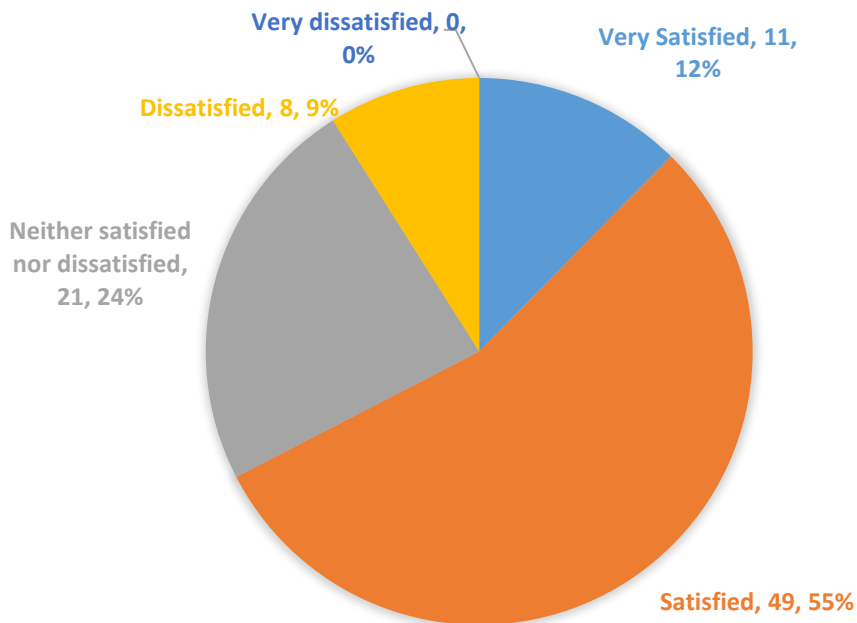
## COURSE STRUCTURE OF THE PROGRAMME YOU ARE PURSUING IS



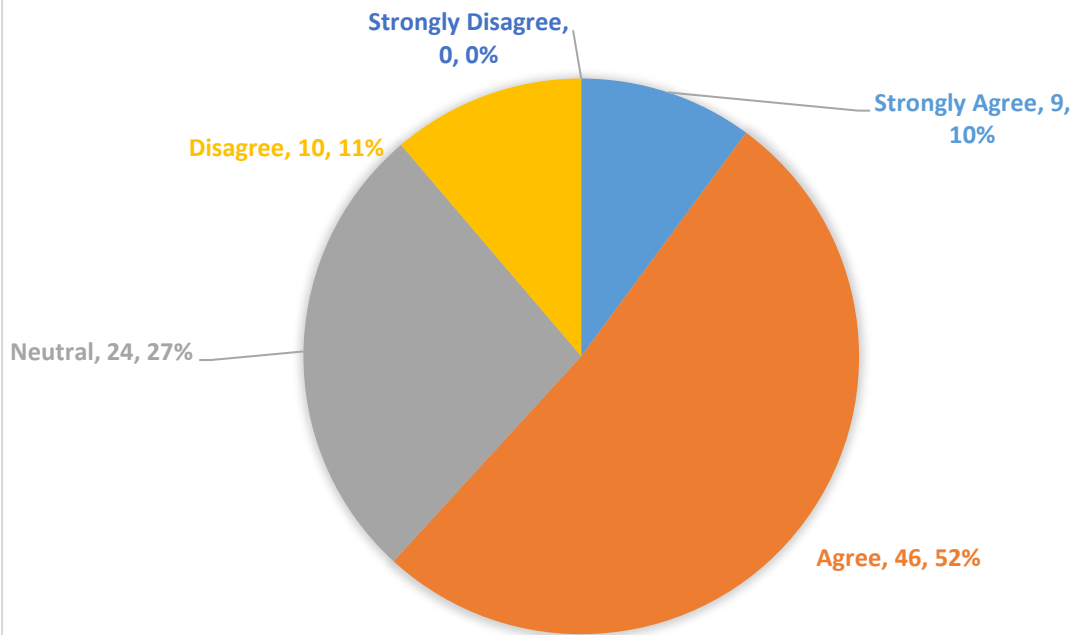
### NUMBER OF COURSES IN THE SEMESTER IS



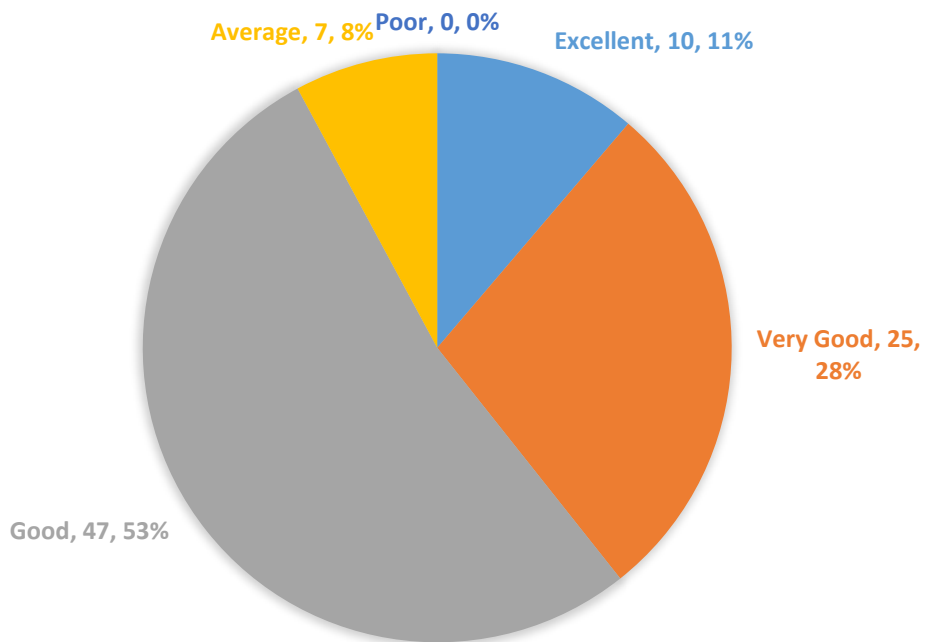
### HOW SATISFIED ARE YOU WITH THE KNOWLEDGE YOU GAINED FROM THE COURSES?



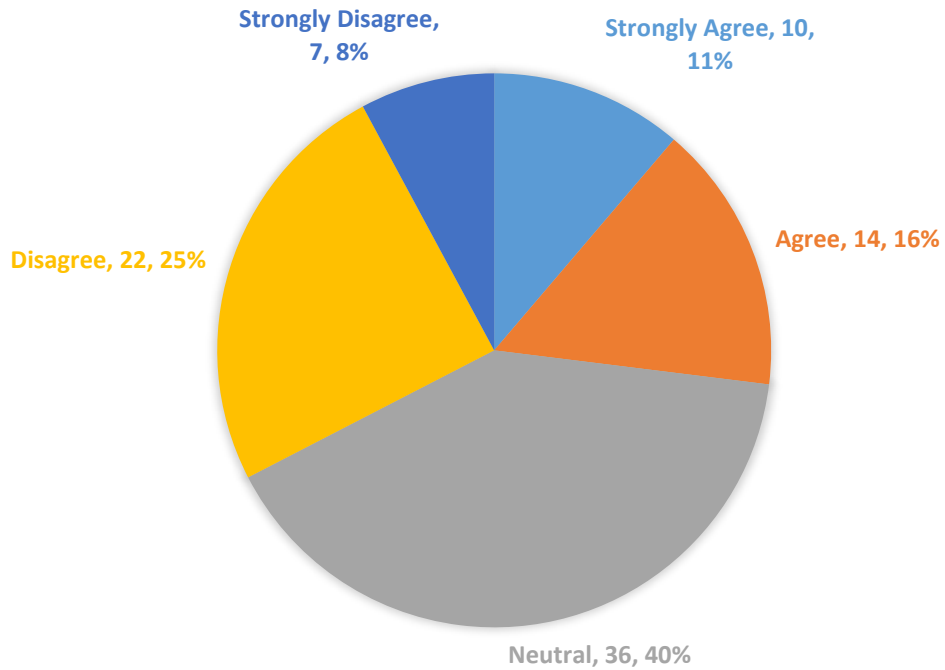
### THE CURRICULUM OF THE COURSES HELPED IN ACHIEVING THE DESIRED LEARNING OUTCOMES.



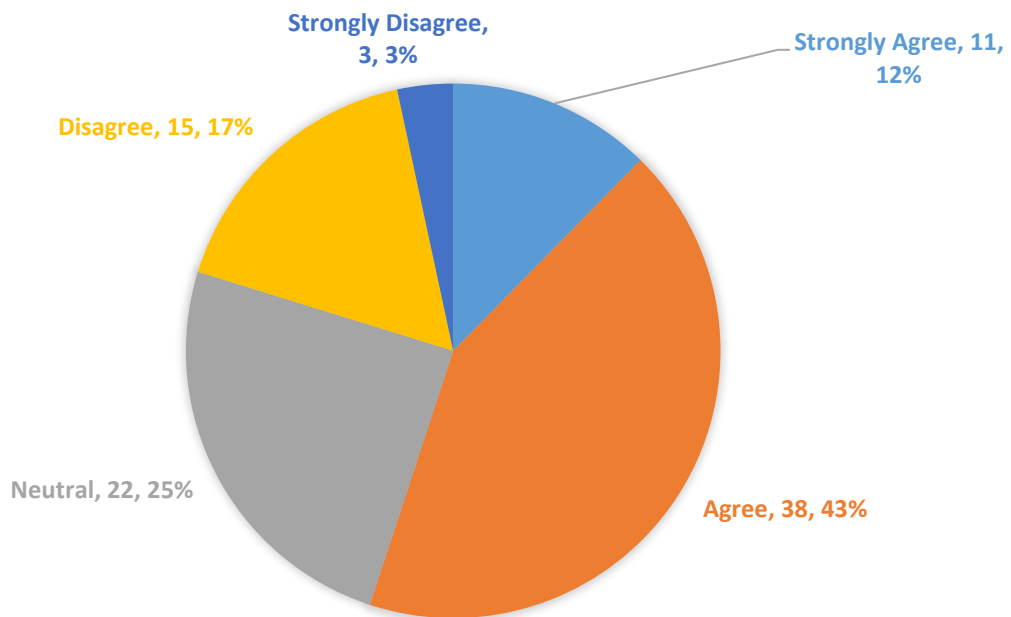
### OVERALL QUALITY OF THE SYLLABUS OF THE COURSES



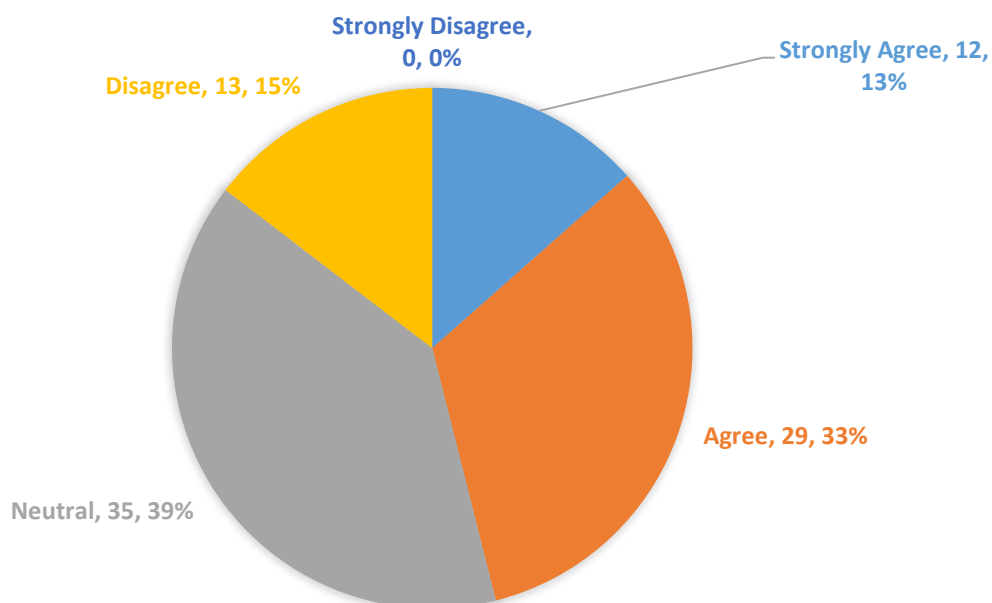

The students were asked to give suggestions to review and improve the syllabus. Out of the total students who have filled up the feedback form, 39 students have responded with certain suggestions or comments. Remaining students did not give any suggestion. The most commonly occurring suggestions in the student's responses would be appreciated as their most common suggestions for the review and improvement of the syllabus in future.

Following suggestions were made by the students

Sl. No.	Suggestions
1.	Regular seminar and conference should be conducted.

2.	Law and Justice in a globalising world needs a immediate change w.r.t syllabus. It's syllabus is concerned more with jurisprudence and lacks the main focus on essence of "law and justice in globalising world".
3.	Class presentation on topics should be promoted more
4.	More emphasis on real world interaction with the subjects.
5.	The syllabus should be designed as per the requirements of the evolving practices especially in commercial litigation. It should be more focused on practical application of the subject.
6.	Syllabus must focus on recent trends and judgments as well.
7.	The syllabus must cater to relevant portions and its day to day applications instead of being a bulky and irrelevant part of the concerned subject.
8.	Syllabus should be shorter for higher marks output of students.
9.	World history must be replaced with development of legal systems around the say for example understanding the common law system and scandavinian system
10.	The focus should be on criminal law. Contemporary legal issues must be discussed in the class room.
11.	In 5th semester we have to study 6 paper, jurisprudence, cpc, company, labour law, management. It would be very difficult to manage and learn all these subjects. Also last time in cpc even half of the syllabus was not completed. It's a great loss for us. It must be divided into 2 semester. There is no need to study labour law in 2 semester.
12.	For my point of view there is need to improve the ADR syllabus. In Adr we just understand the objectives and look into the overview of all the topics and not studied deeply. But nowadays the relevance of this area is increasing so need to change the syllabus.
13.	Mechanism should be there to ensure that the syllabus is covered by all faculty.

14.	Syllabus should cover the portion relevant in practical life proceedings and effort should be made to cover the syllabus and abide by it.
15.	The course focuses a lot on history rather than on contemporary issues. Even if a module is added for discussing them, it is very difficult to reach that module as, usually it is the last one.
16.	Focus should be on encouraging students to create new knowledge and not merely stick to the existing research.
17.	Non-credit subjects should also be given some weightage, ex- psychology. No classes are taken as of now.
18.	Syllabus can include more practical aspects instead of outdated theoretical aspects.
19.	Better learning outcomes with PIL, drafting with Cr.P.C. .research projects must be replaced with interview minutes submission for sociology of law
20.	I think the number of course for history, sociology and political science shall be reduced from 3 to 2, at maximum throughout the 5 year curriculum.
21.	IPC being an exhaustive substantive code must be covered in details as it is vital in judicial exams and civil service exams as well. Which i don't believe can be covered in one semester. We may have 7 subjects in 3rd semester or even in 4th but appropriate knowledge should be provided to the students.  Faculties feedback form marking should be taken care of.
22.	Number of classes should be increased.
23.	CrPC being a most important procedural law must be taught in two semesters.  Labour laws are given two semesters. Which might be merged in one as compared to vast syllabus of CrPC.



	As stated in earlier forms also IPC was inclusive of PCA, POSH act and many other. Which are left out. Hence, syllabus should cover the IPC, CrPC in two semesters.
24.	Include contemporary issues. Deal with topics with reference to new conflict as well as old, some teachers are old machine and teach what they are teaching from past 10 years they don't even know the recent development.. they know bare act development but not cases .. they don't even make student read judgement or teach them any judgement. Must include one topic where famous and important case judgement should be throughout discussed in each and every law paper. And focus on students rather than syllabus completion.
25.	Evidence law should be taught in accordance with the topic, not the sections. The syllabus for Transfer of Property should revamped or the faculty should be changed.
26.	Either the number of classes should be increased or syllabus should be reduced, so that the students do not confined themselves to pass the exam.

**Any other aspect related to the review and design of syllabus that should be covered in the feedback form in your opinion.**

Out of the students who have filled up the feedback form, only 26 students have responded with certain suggestions or remarks. Remaining students did not give any suggestion. Instead of giving the suggestion regarding the aspect that should be asked in the feedback form. All the students have made suggestions regarding the syllabus. The most commonly occurring suggestions in the student's responses would be appreciated as their most common suggestions.

Sl. No.	Suggestions
1.	Discussion session on current legal topics should be there.
2.	Frequent discussions on legal topics.
3.	The syllabus can be simplified
4.	Apart from syllabus, incorporate some practical aspects of law. Especially, in corporate law.
5.	Questions asked in exam of end semester must be choice based from more than 5 questions.

6.	"Indian Partnership Act, Sales of Goods Act and Limited Liability Partnership Act, 2008) were not even touched lectures must be allotted in pre mid Sem period to ensure they are covered."
7.	Syllabus should be designed in such a way that it's use in practical life can be deduced.
8.	"The project for every paper should not be a research project. Book review, article review, film review, etc can also be used as project rather than research project." "
9.	Additionally, i think CPC should be taught in 2 semesters, considering we are unable to finish the entire syllabus, let alone the law of limitation in the course of 1 semester only. Also, i think subjects like criminal psychology, victimology, psychology etc could be introduced in the course.
10.	"IPC should be taught in two semesters."
11.	Hostels should be opened during internships.
12.	I think we need to include one more law paper in first year and second year so that burden should be reduced in third year. And if possible try to make procedural laws in 2 semester.
13.	Include practicality in subject. Teach and guide in prevailing issues and practicality of things.
14.	CPC and Company law two vast subjects are Assigned in this particular semester, nevertheless to mention jurisprudence I and Constitution law I are also there. Need to bifurcate these subjects or exchange either of them with ADR or Administration law in sixth semester.
