




## Student Satisfaction Survey (SSS) Report on Overall Institutional Performance for the Academic Year 2023-24


A Student Satisfaction Survey was conducted to assess the overall institutional performance of the Chanakya National Law University, Patna during the Academic Year 2023-24. Section I of the survey comprised of twelve (12) questions related to the general information pertaining to the student participating in the survey. Section II of the survey comprised of twenty-one (21) questions related to the overall institutional performance of the University during the year. Out of these twenty one questions in the survey, twenty questions were objective in nature and covered various aspects such as, Relevance of the Curriculum, Knowledge and Understanding of the Teachers, Extracurricular activities, Integration of Crosscutting issues into the Curriculum, Imparting of Employability Skills, Fairness of the Internal Evaluation Process, Internship and Field visit Opportunities, Mentoring Process of the University, Use of ICT tools and online resources for teaching and learning process, and Students' participation in various co-curricular activities, extracurricular activities and committees for continuous quality improvement etc. One question was open ended question that aimed at eliciting suggestions by providing the students an opportunity to give suggestions and observations in their own words.


A total of 96 students participated in the survey. Out of the 96 responses received, 41 were from the students pursuing B.A., LL.B. (Hons.) programme, 35 from the B.B.A., LL.B. (Hons.) programme and 20 responses were received from the students pursuing LL.M. programme. Their response was saved and analysed. 






















































## Any other suggestion that you would like to give to improve the overall performance of the institution

The students were asked to give suggestions to improve the overall performance of the institution. Out of ninety-six (96) students who had participated in the

Student Satisfaction Survey, seventy-six (76) students have responded with certain suggestions or observations to improve the overall performance of the institution. Twenty (20) students did not give any suggestion. The most commonly occurring suggestions in the student's responses ought to be appreciated as the most general expectations of the students from the University and their most common suggestions for the improvement of the overall performance of the institution.
