3. Terms and Conditions:

- i) The successful bidder shall enter into the agreement on PWD Form F2 failing which on **Rs. 1,000.00 (Rupees One Thousand) non judicial stamp paper** within (10) **ten working days** from the **date of issue of work order**.
- ii) If the contractor shall desire any extension of the time for completion of the work, on the ground of his having been unavoidably hindered in its execution or on any other ground other than those mention in clause of F2 agreement, he shall apply in writing to Competent Authority within 40 days from the date of starting of the hindrance on account of which be desires such extension as aforesaid and the Competent Authority shall, if in his opinion (which shall be final) responsible grounds be shown thereof authorised such extension of the time, if any, as may in his opinion be necessary or proper.
- iii) If at any time after the commencement of the work the Government of Bihar shall for any reason whatsoever not required the whole thereof as specified in the tender to be carried out, the Competent Authority of CNLU shall give notice in writing of the fact to the contractor who shall have no claim to any payment of compensation whatsoever account of any profit, advantage, which he might have derived from execution to the work in full, but which he did not derive in consequence of the full amount of the work not having been carried out neither shall he have any claim for compensation by reason on any alteration having been made in the original specification, drawing, designs and instruction which shall involve any instalment of the works as originally contemplated clause 12 (a) as per F2 agreement.
 - a) The contractor shall not be entitled to claim any compensation for loss suffered by him on account of delay by or on behalf of the Government in the supply of materials as stores which the Government may have undertaking to supply where such failure is due to:
 - i) Natural calamities, (ii) act of enemies (iii) transport and procurement difficulties or (iv) circumstances beyond the control of the State Government.

In case of such failure in delay in supply of materials or stores on an application by the contractor within 30 days from the date of such failure or delay such extension of time shall be granted to the contractor for completion of the work as shall appears to the Engineer to be reasonable in accordance with circumstances of the case. Payment will be released after the satisfactory report of competent authority for successful completion of work after necessary deduction as mentioned hereunder:

- i) **Applicable TDS** will be deducted from the bill of total amount without tax as per the provision of Government of India and certificate for the same will be issue,
- ii) **Applicable amount** will be deducted from total GST

6. Agreement and Performance Security:

- i) Successful bidder will be issued a letter of acceptance. After receipt successful bidder shall enter into the agreement on PWD Form F2 failing which on **Rs. 1,000.00 (Rupees One Thousand) non judicial stamp paper** within (10) **ten working days** from the **date of issue of work order**.
- ii) EMD shall be adjusted in amount of performance security. Successful bidder will deposit amount of performance security 3% of agreement value, in form of NEFT / RTGS / DD at the time of agreement. Thus, initial performance security will be @ 5% (**Five Percent**) of the agreement value along with additional performance as applicable balance 5% of performance security will be deducted from on account running bills. Performance Security will be refundable after 60 days of successful completion of defect liability period i.e., Two Years. No interest will be payable on the earnest money as well as Performance Security.
