<p>After detailed deliberations on various Reports prepared by the IQAC such as, Student Satisfaction Survey Reports for the Years 2022-23, 2021-22 and 2022-21, Analysis Reports of the Student's Feedback, Teacher's Feedback and Alumni's Feedback on the Syllabus, prepared by the IQAC, the University took major initiatives towards improving the overall teaching learning process in the University. The governing bodies of the University asked the Vice Chancellor to improve the IT infrastructure of the University. Accordingly, towards improving the IT infrastructure the University took the decision to convert all the existing classrooms into digital/smart classrooms. Contracts for converting all sixteen (16) classrooms and two (02) Seminar/conference halls was awarded to the Bihar State Electronics Development Corporation Ltd. (BELTRON), a Government of Bihar Undertaking. All the aforementioned sixteen (16) classrooms and two seminar/conference halls of the University were converted into the Digital/Smart Classrooms.</p>	
<p>Establishment of Language Lab and Accessibility Lab: Taking into consideration various analysis reports, the governing bodies of the University approved the proposal for the establishment of Language Lab and Accessibility Lab. The establishment of the Language Lab and Accessibility Lab were initiated. The University has established a functional language lab.</p>	
<p>Recommendations for Adoption of Elective Courses in the Under-Graduate B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) Programme: The governing bodies of the University took note of the Student's concerns about the non-credit subjects. Accordingly, Fifteen (15)</p>	

single credit elective courses were offered by the faculty members of the University. Out of these fifteen courses, nine (09) single credit courses were opted by the students. Seven courses of single credit courses were smoothly conducted and successfully completed. The University has introduced the scheme of visiting elective papers.

Academic Reforms Pertaining to Multiple Types of Project Assignments and Segregated Presentations: Taking into account the Reports prepared by the IQAC, on Student's feedback and Student Satisfaction Survey Report, the governing bodies of the University approved major academic reform initiative pertaining to the mandatory written project assignment. Under the hitherto existing practice each student was required to write five to six original research papers as project assignments every semester, which was quite cumbersome. The governing bodies of the University approved the proposal that out of the five or six project assignments, each student will be required to write one Research Paper and the remaining project assignments may be Case Comment, Bill Review, Policy Review, Newspaper Discovery, Film/OTT Series/Documentary Review, Book Review or Response Articles. While this has helped the students to choose project type as per his choice in a given course, it has helped the University to identify and nurture the multiple intelligence of the students. Under the policy the presentation of different types of projects are to be scheduled on different dates which further help the course instructors to prepare a segregated presentation schedule and helps the students in giving their presentations.

17. Multidisciplinary / interdisciplinary	
<p>Chanakya National Law University, Patna is actively engaged in teaching-learning and research activities in law and allied disciplines. It is one of the objectives of the University to provide quality multidisciplinary education in legal studies, keeping in view the demands of the global economy on the one hand and the needs of the domestic society on the other. The University has been offering the Five Year Integrated Undergraduate B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) programmes, One Year LL.M. Programme and Doctoral and Post-doctoral research degree programmes. The University has consistently strived to provide instruction in all branches of knowledge or learning pertaining to law and such allied subjects as necessary and deemed fit. The five year integrated programme in law viz. B.A, LL.B. (Hons.) and B.B.A., LL.B. (Hons.) helps the students develop an interdisciplinary approach as knowledge in the respective liberal stream subjects help them immensely in understanding and interpreting a law in a much better way in a given situation. The curricula of the UG programmes such as B.A., LL.B. (Hons.), B.B.A., LL.B. (Hons.) programmes and the One Year LL.M. programme consist of the credit based courses and the project assignments are compulsory component of the courses. Presentations on the assigned project topic is an integral part of the learning and evaluation process.</p>	
18. Academic bank of credits (ABC):	

Chanakya National Law University adheres to the mandates and statutory obligations of UGC, NAD (National Academic Depository)-ABC (Academic Bank of Credits). NAD-Digilocker is one of the significant components of ABC portal as per the UGC letter dated 2nd May, 2023 with regard to uploading the data through the repository model, and therefore, the University took its initiatives in the implementation of NAD-Digilocker framework through University registration. The implementation of uploading the relevant data on NAD portal has been undertaken since 2021. CNLU has been registered under NAD-Digilocker portal successfully on 12/07/2022 (noreply-digilocker@gov.in). After successful registration on the NAD-Digilocker portal the templates for degree certificates of the University was finalized. This process took a lot of time as the portal itself was getting developed by the UGC. The uploading of the documents (University Certificates) started since September 2022 which can be certified by the response, we received on 24/09/2022 (noreply-digilocker@gov.in). Initially about 72 files were uploaded and later on it was increased up to 532 which can be accessed through the monthly report of the records uploaded by the Universities in Bihar. The University received this monthly report via email on 04-02-2023, Digi Locker NAD Monthly Report, Bihar. On 23rd February, 2023 University received an email titled "Advisory from the Secretary UGC regarding ABC" in which the Government of India, under the New Education Policy, 2020 has launched the Academic Bank of Credits scheme and the University Grants Commission, with the concurrence of Ministry of Education has notified "The University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) regulations, 2021 in the Gazette of India on 28th July 2021. The University started working on the UGC advisory on ABC once it received the mail regarding that. We started analyzing the ABC documents and constantly participated in the various online sessions on its significance for the University in moving ahead in the direction NEP ,2020. Our University also registered in ABC portal for realization of this system in the University system. To make it functional we viewed and accessed the documents which is required for better implementation of this project. On dated 10/04/2023 we also received Step by Step User Guide for Using Multiple Channels to Create ABC ID for Students & Academic Institutions. The University studied the same and going to ensure registration of students on ABC portal by upcoming semester. During the academic session 2023-2024 total four meetings have been held with the UGC NAD Coordinators. It was concluded that the University Degree Marksheet (DGMST-7) Template and the University Degree Certificate (DGCER-18) Template would be adopted. Total 3,358(degree & Marksheet) awards have been uploaded, out of which 868 are University Degree Certificates and

2,490 are University Degree Marksheets. Total 298 ABC accounts have been created by students of Chanakya National Law University.

19.Skill development:

The Center for Innovation, Incubation & Legal Entrepreneurship (CIILE) & Startup Cell of Chanakya National Law University (CNLU), Patna is actively engaged in organising skill development programs. In the academic year 2023-24, the CIILE & Startup Cell of the Chanakya National Law University, jointly conducted various activities to promote innovation, legal education, and entrepreneurship. Several skill development programs were organized, such as the "Startup Awareness Program" (July 12, 2024), and "NISM Workshop on Stock Market" (Jan 19-20, 2024) on investment strategies, risk management, and market analysis. Another significant skill development program was conducted on Commercial Contracts (March 9, 2024) on drafting and interpreting key commercial agreements. In the domain of online skill development programs, CIILE & Startup Cell also actively engaged in hosted skill development sessions on Marketing Strategy for Startups (June 30, 2024), Entrepreneurial Ecosystem (May 28, 2024), and Entrepreneur Skill & Resilience (Feb 28, 2024) equipped participants with essential entrepreneurial insights. Other highlights included the Design Thinking (Feb 27, 2024) focuses on human-centered innovation, and the IPR and Startups (July 26, 2023) on intellectual property rights and legal protections. On the front of IPR-focused programs, events like Investigating Trademarks in the Digital Age (Dec 27, 2023) and the Trademark Prosecution Workshop (Jan 31, 2023) provided participants practical skills in protecting intellectual property.

20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

One of the objectives of the University as provided in the Chanakya National Law University Act, 2006 [Act No. 24 of 2006] is to promote the cultural, legal and ethical values with a view to promote and foster the rule of law and the objectives enshrined in the Constitution of India. The University has continuously and consistently strived to actively work towards fulfilment of the aforesaid objective along with the other objectives incorporated in the Act No. 24 of 2006. While the course structure of the professional programmes such as the B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) programmes are designed as per the guidelines of the statutory regulatory authority that is Bar Council of India, special care has been taken to ensure that the Indian knowledge system especially the knowledge about the Indian Culture and ethical values especially those pertaining to the professional ethics of

lawyers are integrated into the course curriculum of the relevant and suitable courses. Wherever necessary, either a full separate course has been incorporated or modules and units are inserted in the suitable courses to achieve the objective of promoting cultural, legal and ethical values including Indian culture and knowledge system. As students from divergent background take admission in the Under-Graduate and Post-Graduate programmes offered by the University, keeping in view the different learning levels and especially the slow learners' requirement related to written and oratory skills, the faculty members teach bilingually whenever needed. The University enthusiastically organises and promotes its students to actively participate in various cultural events and programs to commemorate significant days of historical and cultural significance such as Hindi Divas, Youth Day, Yoga Day, Teachers Day, Constitutional Day, etc.

21.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The University realises the significance of the Outcome Based Education (OBE) and aims at evolving and imparting comprehensive legal education at all levels to achieve excellence. As the objective of the undergraduate B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) programmes inter alia is to prepare young law graduates competent and willing to work as social engineers, the course structure and the curricula for these programmes have been designed focussing upon the desired outcomes that would facilitate achieve the objectives. Likewise, for the One Year Post Graduate LL.M. programme, course structure and curricula has been designed keeping in mind the programme objective of producing the graduates eligible to teach in and serve the higher educational institutions. Curriculum of each and every course is designed by including the units/modules with the appropriate teaching methodology and resources that helps in achieving the desired learning outcomes for the particular course. The course structure of the programmes in turn has been prepared, broadly keeping in view the guidelines of the statutory regulatory authority for legal education in the country, that is Bar Council of India(BCI), so that the learning outcomes of the entire courses lead to fulfilment of the guidelines and simultaneously achieve the desired outcome of the concerned programmes. Syllabus of the courses is prepared by the faculty members meticulously, and contains the learning outcomes of the respective courses. Learning outcomes of all the courses under different programmes offered by the University are specified in the syllabus of the respective courses that are uploaded on the institutional website of the University. Faculty members who are the course instructors are required to adopt the appropriate

teaching methodology that would best serve the objective of achieving the stipulated course outcomes. In setting the question papers for the examinations, it is specially kept in mind that the question papers framed can assess the learning outcomes achieved.

22.Distance education/online education:

As per the norms of the statutory regulatory authority for legal education in the country, that is Bar Council of India(BCI), the Undergraduate programmes namely the Five Year Integrated B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) programmes offered by the Chanakya National Law University, Patna are run through the regular mode only. At present the University is not offering any programme through the distance or online mode. The University, however, has the requisite IT infrastructure for offering the online course. During the Covid pandemic for example, the University had successfully provided online education by conducting online classes for all the courses of the various Undergraduate Programmes such as B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) and the Postgraduate programmes of different LL.M. on the Microsoft Team platform. The teaching staff of the university are well versed with the technical nuances and knowhow of conducting the online classes through various platforms such as MS-Team, Google Meet, Zoom and Cisco Webex etc. The University has a robust ICT infrastructure that facilitated smooth conducting of the online classes successfully during the COVID pandemic. Teachers have successfully demonstrated their capability of conducting online courses by 1. creating EContent in the form of PDF files, PPTs, Word Document and providing their access to the students by uploading them on their respective MS Teams Classroom; 2. scheduling and delivering meaningful and engaging live online lectures; 3. recording their online lectures and making recorded videos available in their respective MS-Teams Classroom ensuring increased and enhanced access to the students; 4. holding online sessions for presentations of the project topics assigned to the UG and PG students; 5. addressing the queries and clearing the doubts by using the enhanced communication channel in the form of chat through MS-Teams app as well other social media such as WhatsApp group etc. The University, therefore, is capable of and seriously contemplating to commence programmes particularly the PostGraduate Diploma programmes and Certificate Courses through distance and/or online mode. For the aforesaid purpose the University has already started planning. At present the University has converted all its classrooms into digital / smart class rooms and has the requisite infrastructure to offer the online courses.

The Programmes offered by the University are specifically geared to the current requirements and demands of the global economy on the one hand and the regional and domestic needs on the other.

Undergraduate Programmes of the University aim at following outcome:

Curricula of B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) are framed in adherence to the norms of rules of legal education as prescribed by the Bar Council of India, ensuring quality legal education to prepare law graduates competent and willing to work as social engineers eligible to enrol at bar and practice as lawyers in the courts. The curricula are designed and developed keeping in mind the evolving and changing needs of the society in general and the legal profession of the country in particular. Curricula of LL.M. programme are framed with the objective that students are prepared and qualified to teach and conduct research in the higher educational institution imparting legal education and thereby serve the society and the nation. The Doctoral and Post Doctoral Programmes are aimed at exploring the new challenges and in-depth research in the dynamics of law.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

Teachers of the University use various student centric methods including experiential learning, case law method, group discussions and problem-solving method to enrich the learning experience of students coming from diverse backgrounds. Students of B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) programmes are encouraged to

participate in General and Special Intra Moot Court Competitions, Debate Competitions which are organised every semester to get the practical experience and enhance their advocacy skills. Throughout the semester, teams comprising of students are selected on the basis of these competitions, to represent the University in various National and International Moot Court, Arbitration and Client Counselling Competitions. Project Assignment is part of the curriculum in each of the courses, where students are required to prepare and submit the written project report and make a presentation of the same before the faculty and other students. Internships form an integral part of the experiential learning opportunities for the students of the University. Winter and summer internship dates are announced in well advance in the Academic Calendar itself. The case law method of teaching is followed in all the substantive and procedural law courses, which is very effective in developing the analytical and critical skills amongst the students and enhances their learning experiences. Community service in the form of legal aid programmes and other outreach programmes, is very effective as participative learning methods. The students are given problem-based questions during the class lectures and encouraged to solve the problems with the help of decided cases.

2. The Centre for Innovation, Research and Facilitation in Intellectual Property for Humanity and Development (CIRF) conducts research and innovation in Intellectual Property and interconnected areas, conducts action research, seminars and training programs for various stakeholders.

3. Child Rights Centre (CRC) engages with Child Rights from multidisciplinary perspective, and has contributed to policy, law and practice through research, training and advocacy in this area.

4. Centre for Advanced Research on Corporate and Insolvency Law (CARCIL) carries research, disseminates knowledge generated in Corporate, Insolvency and allied laws by conducting conferences, seminars and training programmes.

5. Chanakya Centre for Alternative Dispute Resolution (CCADR) aims at skill development, promoting different dispute resolution methods, involve in the policy framework related to ADR, and conduct competitions, workshops.

6. Centre for Law and Economics (CLE) Centre has been established with the aim to conduct interdisciplinary research in law and economics and create and disseminate knowledge in economic analysis of law.

7. The Chair for Panchayati Raj (2018) and DPIIT chair (2023) have been established to support and train PRIs and to support researchers in IP creation, protection and commercialisation respectively.

The University encourages its faculty members to engage in consultancy roles and provide their expertise to government agencies, international organisations, non-government organisations and private sector companies. This consultancy policy outlines the revenue-sharing arrangements between the University and individual faculty members involved in specific consultancy projects. Various mechanisms like MoUs, Chair Professors and specialised research centres and committees facilitate these consultancy projects. These centers and professors have conducted training programs for stakeholders such as members of the Juvenile Justice Board (JJB), the Central Adoption Resource Authority (CWC), and participants from Panchayati Raj Institutions (PRIs). Furthermore, through the MoUs with different organizations, faculty members have served as resource persons for various training initiatives.

Circulation history of issued books, overdue books and charges, and frequently circulated books can be tracked easily through the system. The University has a well developed system and procedure for maintaining and utilizing physical, academic and support facilities. Under the campus development projects, field levelling, landscaping,

parking, drainage, electrical cabling, electric sub-station, grill Works and concertina wire work for safety, roads inside the campus, Air Conditioners (installed in the class rooms, Guest House, faculty chambers, library and university offices), Fire Safety system and water sprinklers etc. have been regularly maintained. The university has an engineering section, which maintains the infrastructure facilities of the University campus through outsourcing agencies. As far as utilizing the physical, academic and support facilities is concerned, the University has a well developed mechanism in place. For using the academic facilities such as class rooms, seminar halls, conference halls etc. for activities other than the routine lectures, curricular and co-curricular activities, permission has to be sought from the University authorities such as Registrar of the University. Library, Sports, Gymnasium, Indoor and Outdoor Games facilities are available for the students and staff as per the rules made by the respective body or authority of the University. For the purpose of activities such as Moot Court Competitions, Academic and Debating Competitions, Youth Parliament Competitions, Model United Nations, Sports Tournaments, Cultural events etc. the respective committees (Moot Court Committee, Academic and Debating Committee, Sports Committee, Cultural Committee etc.) comprising of faculty convenor and members and student members approach the University authorities with a proposal and application in that regard and with the permission of the authorities utilize the facilities.

After deliberations on various Reports prepared by IQAC such as, Analysis Reports of the Student's Feedback, Teacher's Feedback and Alumni's Feedback on the Syllabus, the University took major initiatives towards improving the overall teaching learning process. Towards improving IT infrastructure the University took the decision to convert all the existing classrooms into digital/smart classrooms. All the sixteen (16) classrooms and two (02) seminar/conference halls of the University were converted into the Digital/Smart Classrooms. Taking into account these Reports the governing bodies of the University approved major academic reform initiative and approved the proposal that out of the five or six project assignments, each student will be required to write one Research Paper and the remaining project assignments may be Case Comment, Bill Review, Policy Review, Newspaper Discovery, Film/OTT Series/Documentary Review, Book Review or Response Articles. While this has helped students to choose project type as per his choice, it has helped the University to identify and nurture the multiple intelligence of the students. Under the policy, presentation of different types of projects are to be scheduled on different dates which further help the course instructors to prepare a segregated presentation schedule and helps the students in giving presentations. Following contributions were also made by IQAC:

Also, the University organizes workshops, programmes, and seminars to sensitize the students and staff towards the same through its various cells and specialised centres (CNLU Annual Report 2023-24). The University students and staff take a deep interest in celebrating the Constitution Day of India.
