IMPORTANT GUIDELINES REGARDING THE SUBMISSIONS

Authorship

- Co-authorship up to TWO authors is allowed.
- Academicians, professionals, doctoral researchers are invited to submit their work.

Word count

- Long Articles are typically of around 6000-10000 words.
- Short Articles are typically of around 4000-8000 words.
- Case Analysis
- Book reviews are generally around 2500 words. Submissions to this category must critically analyse the ideas and themes explored in the book instead of merely providing a summary of its main arguments.

All the above-mentioned word counts are inclusive of footnotes.

Format & citation

- Each submission (except Book Review) should be accompanied by an abstract of not more than 300 words and five keywords.
- Authors must indicate their name, academic qualifications and the name of the university/institution to which they are affiliated.
- Font type and size of the main text must be Times Roman, 12.
- Font type and size of the footnotes must be Times Roman, 10.
- The main text must have a line spacing of 1.5; Abstract & Footnotes line spacing must be 1.
- The permissible plagiarism limit is 10% & AI should be 0%
- Footnotes to be used for citing the sources. Citation style must adhere to ILI. No references & bibliography.
- Manuscripts must be in MS-Word (doc./docx.) format.

CONDITIONS FOR PUBLICATION

Declaration by the Author(s)

- 1. The author(s) must declare that the research paper is original work, and he/she has no conflict of interest with the Publisher/CIRF-in-IPHD/CNLU.
- 2. That the research paper is unpublished and has not been sent to/accepted for publication by any other publication(s).
- 3. Once the research paper is accepted, for publication, it shall not be withdrawn, even if there is a delay in publication.

SUBMISSION PROCESS

- The name of the word file should be the Author's Name.
- The subject of the mail should be the Name of the journal along with the Volume and Issue.
