



supports both economic prosperity and societal well-being.





Chanakya National Law University Patna celebrated the INAUGURAL CEREMONY of the DPIIT-IPR Chair and organized a one-day seminar on "INTELLECTUAL PROPERTY RIGHTS AND HUMAN CAPITAL DEVELOPMENT."

The dignitaries on the dais included Mr. A.K. Jain (Former Law Secretary, Government of Bihar), Dr. B.P. Singh Raman (Former Deputy Director, Indian Patent Office), Prof. Dr. Raman Mittal (University of Delhi), and other distinguished resource persons.

The seminar focused on one of the objectives of the National IPR Policy 2016, which talks about strengthening and expanding human resources. The national seminar was followed by five parallel technical sessions, where more than a hundred participants presented papers through online and offline modes. The valedictory ceremony was graced by the Vice Chancellor, Hon'ble Justice Mridula Mishra, who also inaugurated the IPR Chair. Human intellect is the creator of intellectual property, with the investment of labor, skill, and judgment, generating rights in the property, known as intellectual property rights (IPR). These are exclusive rights granted to the creators for their creations. Intellectual property rights include patents, copyrights, trademarks, industrial designs, geographical indications, trade secrets, layout designs for integrated circuits, traditional knowledge, plant variety and farmers' rights, biotechnology, and agriculture, among others. It is a legal concept that refers to creations of the mind for which exclusive rights are recognized. The policy recognizes the abundance of creative and innovative energies flowing in India and the need to tap into and channel these energies toward a better and brighter future for all. It views IPRs holistically, taking into account all disciplines, and aims to create and exploit synergies between all forms of intellectual property (IP), concerned statutes, and agencies. It establishes an institutional mechanism for implementation, monitoring, and review, and aims to incorporate and adapt global best practices to the Indian scenario.

The objective of the session was to educate and inform people about job opportunities through G.I. and Plant Breeder's Rights protection.

Bihar, with its rich cultural heritage and diverse agricultural practices, offers numerous opportunities in the fields of Traditional Knowledge, Geographical Indications (GIs), and Plant Breeders' Rights (PBRs). Traditional knowledge in the state is deeply rooted in local customs, crafts, and agriculture, presenting a significant potential for commercialization, especially in sectors like handicrafts, Ayurveda, and organic farming. GIs, which protect products tied to a specific region, can help in promoting Bihar's indigenous products such as Madhubani art, Sikki grass, and Shahi litchi. These products, when registered under GIs, not only safeguard the local heritage but also create business avenues through national and international markets

Plant Breeders' Rights, by encouraging innovation in agricultural practices and crop breeding, can boost Bihar's agricultural productivity. These legal rights provide breeders with exclusive control over new plant varieties, offering incentives for research and investment. Together, these sectors can transform Bihar into a hub for sustainable development, providing employment and fostering regional economic growth.


