1. Education: B.A.LL.B. /BBA.LL.B. /LL.B. degree, having not less than 60% marks from Indian University, or equivalent degree from accredited Foreign University.
2. Proficiency in English language and Computer application-data entry.
3. Understanding in Intellectual Property Rights Laws and creative writing abilities.
4. Ability to organize workshops/ seminars/ events/ discussions and extension activities/field work, etc.
5. Preference would be given to candidates having work experience with Research projects/Centres/ IPR Chair.
6. At least one research paper published in IPR, in a peer reviewed journal.

##### **❖ NATURE OF WORK:**

1. Undertaking research in Socio-economic-legal, technological and entrepreneurial aspects on emerging IPR issues under the guidance of the Chair.
2. Helping the Chair in setting up of a repository for IPR related information and case studies at the Universities both in physical and electronic form.
3. Helping the Chair in preparation of resources / instruction materials for various levels of IPR courses in education services for direct teaching as well as teaching through distance education mode / online courses

4. Helping the Chair in facilitating of filing of IPR applications
