FIRST ADMISSION NOTICE AGAINST THE VACANT SEATS / AGAINST THE SUBSEQUENT VACANCY AT CNLU, PATNA

FOR

POST GRADUATE COURSE (LL.M.), ACADEMIC YEAR 2025-26

Candidates who appeared in the CLAT-2025 Examination and who are *willing* to take admission to Post Graduate Course in our University **against few vacant seats/ against the subsequent vacancy, if any**, can apply under the following categories :

- (i) **General Category** (only those candidates should apply under General Category whose All India Rank (AIR) in CLAT-2025 Examination is **below 2,500** (*Two Thousand Five Hundred only*);
- (ii) **Backward Classes (BC-II)** for Bihar Domicile candidates only whose All India Rank (AIR) in CLAT-2025 Examination is **below 5,500** (*Five Thousand Five Hundred only*) (Right now there is no vacant seat in BC Category but in future should any subsequent vacancy arises, admission would be offered to only those who apply in response to this notification);
- (iii) **Extremely Backward Classes (EBC)** for Bihar Domicile candidates only whose All India Rank (AIR) in CLAT-2025 Examination is **below 7,500** (*Seven Thousand Five Hundred only*);
- (iv) **Economically Weaker Sections (EWS)** for Bihar Domicile candidates only whose All-India Rank (AIR) in CLAT-2025 Examination is **below 4,000** (*Four Thousand only*) (Right now there is no vacant seat in EWS Category but in future should any subsequent vacancy arises, admission would be offered to only those who apply in response to this notification);
- (v) **Scheduled Caste (SC)** for Bihar Domicile candidates only, who have written CLAT-2025 Examination. Admission would be offered to only those who apply in response to this notification);

- (vi) **Scheduled Tribe (ST)** for Bihar Domicile candidates only, who have written CLAT-2025 Examination. (Right now there is no vacant seat in ST Category but in future should any subsequent vacancy arises, admission would be offered to only those who apply in response to this notification);
- (vii) **Person with Disability (PWD)** – Admission would be offered to those CLAT-2025 candidates only who apply in response to this notification.

NOTE:

Under WBC Category, women candidates of Bihar get admission on merit based on All India Rank (AIR) CLAT-2025 rank among (i) Extremely Backward Classes (EBC-BC-I), (ii) Backward Classes (BC-II), (iii) Scheduled Caste (SC) and (iv) Scheduled Tribe (ST).

Interested candidates can apply with non-refundable fee of Rs. 1,000/- against the Vacant Seats/Subsequent Vacant Seats at CNLU, Patna, for Post Graduate Course, Academic Year 2025-26 through the following **Google Form Link only:**

on or before **Monday, the 14th July, 2025 till 4:00 p.m.** and candidates are hereby directed to pay application fee (Non-Refundable) of Rs. 1,000/- (One Thousand only) through the following **ICICI Bank payment Gateway only :**

Please note that if application fee of Rs. 1,000/- (One Thousand only) is not paid or/and not uploaded the required relevant scanned copies of the documents as mentioned in Table A, within the above-mentioned date i.e on or before **14th July, 2025 till 4:00 p.m.**, the candidature of candidate shall not be considered for admission. No further enquiry shall be entertained in this regard.

Candidates will be informed about probability of their admission through our University website, subject to vacancy and admission will be done strictly in order of their All India Rank (AIR) of CLAT-2025 result, through our website from time to time.

Subsequent vacancies, if any, shall be filled in also *only* from those candidates who have applied and have made the non-refundable application fee of Rs. 1,000/- on or before **14th July, 2025 till 4:00 p.m.**

The provisional applicant's list who have filled application form through above mentioned Google Form Link against the vacant seats shall be tentatively published on 17th July, 2025 on the University website i.e. <https://cnlu.ac.in/admission-process/> and the admission process of the provisionally selected candidates shall be started from 19th July, 2025 onwards through online mode.

• PWD Certificate issued by the competent authority, if applied and allotted under PWD Category.*

At the time of online provisional admission, the candidates shall be required to pay the following University fee for the Academic Year (2025-26) through the above-mentioned ICICI Payment Gateway Link, failing which their candidature will be forfeited for the Academic Year 2025-26.
