The competition is open to all the UG and PG students of recognized law schools/universities and colleges, providing an opportunity to contribute to law and economics scholarship. This event provides participants a valuable opportunity to contribute to the legal discourse and gain visibility for their work. The program aims to introduce aspiring legal scholars to the dynamic intersection of law and economics, fostering curiosity and active engagement among students in this multifaceted field.

### **Theme of the Competition**

### "Tariffs, Retaliation, and Rule of Law: Rethinking Trade Conflicts Economically"

Most countries trade, using tariffs—import taxes—to raise revenue, protect domestic industries and increase their GDP. This practice of imposing tariffs is challenged by economists for hindering growth, often fuelling debate amongst the scholars. Recently, New Tariff Policy announced by the President of United State has triggered global tensions: initial imposition of 145% U.S. tariffs on Chinese goods, 125% tariffs on American goods by China as a reaction. India now faces a 50% tariff on its exports to US from August 6, 2025, giving rise to fears that it would lead to setbacks for Indian economy, industries, and cross-border trade. This situation underscores an urgent need for robust legal frameworks and fair negotiations to resolve trade conflicts. In the current milieu of controversial tariff imposition and the concomitant disputes, law and economics scholarship and its tools can provide a more nuanced understanding of the problem and further help in finding mutually acceptable or other possible solution under the existing international trade law regime.

### **Submission Guidelines:-**

- a. The language/ medium of the essay shall be English.
- b. Co-authorship up to max. two authors is allowed. One person can submit only one essay.
- c. Soft copies of manuscripts are to be uploaded in MS Word and PDF format through the google form provided post registration via E-mail.
- d. The name of the file should be saved in the name of the author/ authors.
- e. Submissions are to be made in the form of MS Word (2003 & above) and pdf.
- f. Manuscript word limit: 3500-5000 (excluding footnotes)
- g. The body of the manuscript should be in Times New Roman, size 12 and line spacing 1.5. Headings should be size 14. All text should be justified, with a margin spacing of 1" on all sides.
- h. The contributors' names should not be mentioned on the manuscript.
- i. The footnotes should be in Times New Roman, size 10 and line spacing of 1. The Bluebook: A Uniform System of Citation (20th ed.) should be followed for footnoting.
- j. The authors may include tables and diagrams, which should be numbered consecutively and included in the text. Source must be mentioned below the table.
- k. The manuscript should be error free, original and plagiarism free, with a maximum of 10% similarity allowed.
- l. Essays will also be checked for AI-generated content as use of AI is strictly prohibited. Submissions exceeding maximum AI limit provided in the submission guidelines will not receive Certificate of Participation.

Each manuscript must contain:

- a. Cover page, which must include:
- i. Full title of paper (Times New Roman, bold, font size: 16).
- ii. Name(s) of contributor(s) and designation.
- iii. E-mail and contact number.
- b. Abstract (150-350 words).
- c. Maximum 5 keywords.
- d. References (at the end of the paper, arranged alphabetically).
