(Hons.) and B.B.A., LL.B. (Hons.) Degree for introducing Multiple Intelligence Policy for slow and advanced learners with effect from the Academic Year 2024-25.
- 4. The IQAC considered and recommended to the governing bodies of the University for their approval partial amendment of the Academic Regulations for the 5 Year Law Course leading to the award of B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) Degree for converting the subject specific Honours into general law Honours, for the Academic Sessions 2022-27 and 2023-28.
- 5. The Internal Quality Assurance Cell considered and recommended to the governing bodies of the University for their approval the Annual Quality Assurance Report (AQAR) for the Academic Year 2023-24 prepared and submitted online to the NAAC by the IQAC through the HEI portal of the University.
