### GENERAL TERMS AND CONDITIONS:-

- a) If any bidder withdraws the quotation before the said period, the EMD shall be forfeited, without prejudice to any other right or remedy.
- b) Incomplete and unsigned quotations are liable to be rejected.
- c) Quotation/Bid without EMD shall be summarily rejected. No Cheque/Money Order shall be accepted. The EMD deposit shall not attract any interest.
- d) The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for.
- e) The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- f) No items, once disposed to the successful bidder, shall be taken back by CNLU.
- g) The successful bidder shall be required to lift all the items from the disposal site to his/her premises within 3 (three) days after the payment of the quoted amount (EMD amount will be adjusted with the quoted value). On failure to do so, CNLU shall have the right to forfeit the entire amount of the bidder.
- h) Final decision to accept/reject the bids shall be taken by the CNLU on the basis of eligibility criteria and highest financial quote.
- i) The consolidated price should be inclusive of all miscellaneous charges like transportation, labour or any other expenses etc.
- j) Date & Time for inspection of items will be 01.12.2022 to 02.12.2022 Between 01:00 Noon to 02:00 pm.
  
- k) If L1 denied collecting the materials on quoted price then its EMD shall be forfeited.

### CRITERIA TO AWARD:
