#### <u>Placement Process</u>

- CNLU invites Firms to be a part of the placement process. It can also be downloaded from the website of CNLU.
- ii. Firms need to fill the Job application form which contains the details of the profile. Job application form is made available to the students along with other information furnished by the firm
- iii. Pre-placement talk is scheduled based on the availability of the recruiters
- iv. Based on profile submission shortlisted students participate in the placement process including Written Test, GD, PI which may vary based on recruiter's selection process.
- v. Firm is required to furnish the final list of selected students after the recruitment process
