Chanakya National Law University, Patna invites applications for **Professor of Practice** (on Contract) - Practice Track in the Cyber Security and Cyber Crimes Investigation domain.

The selected candidate is expected to teach in different programmes as per the norms of the CNLU Patna, promote industry-CNLU Patna linkages through consulting assignments/ MDPs and involved in placements and academic activities.

Eligibility Criteria:

- Professionals such as CISOs, ACISOs, CTOs, Director IT with at least a Master's Degree in Computer Science, Information Technology, Computer Applications or equivalent professional qualification from a reputed national or international institution, or a related field can be considered for the position of Professor of Practice.
- A Ph.D. is desirable but not mandatory. However, the lack of a Ph.D. must be offset by the demonstrated domain knowledge obtained from deep experience in the field of designing and teaching cyber security courses.
- Minimum 15 years of managerial or professional experience out of which at least 5 years in designing, developing and delivering Masters / Diploma Cyber Security courses to LEAs, PSUs, Govt Departments, IT Industry is mandatory.
- Globally recognised Cyber Security certifications are must like CISSP/CISM/CISA.

ACTIVITIES

The Professor of Practice is expected to perform a wide range of activities including:

1. Designing, developing and offering of new practice-oriented courses in the domain of Cyber security for designing cyber security and digital forensic training courses for the police and law enforcement officers;

- 2. Advising and guiding students in their projects linking them with appropriate external stakeholders;
- 3. Developing Continuing Education Programs, undertaking outreach activities and conduct extension programmes;
- 5. Encouraging students in innovative and entrepreneurship projects and provide necessary mentorship for these activities; and
- 6. Contribute to enhance industry academia collaborations at CNLU

DURATION

The position is purely contractual and would be for an initial period of three years and on satisfactory performance may be extended for one more year. Based on a rigorous review, Professor of Practice may also be absorbed as permanent Professor of the CNLU Patna after completing three years of contract provided other eligibility conditions as per UGC Regulations are satisfied.

Salary and Benefits:

Negotiable. Generous incentive scheme for the SCOPUS/Web of Science research publications, faculty development fund for attending national and international conferences etc. are also available to the academic staff of CNLU. Faculty members are encouraged to take up consultation assignments.

Age Limit: Maximum 50 years.
