NOTICE FOR ADMISSION TO FOREIGN NATIONALS AND NON-RESIDENT INDIANS (NRIs)

There are five seats for the Foreign Nationals and five seats for Non-Resident Indians (NRIs). Those candidates who wish to apply under these categories for B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) course in our University may apply directly to the University latest by 23rd June, 2025 through the following Google Form link (*Sample of required data for Google Form and documents is enclosed*):

Candidates are hereby directed to pay Rs. 7,500/- (Seven Thousand Five Hundred only) as Application Fee which is non-refundable through the following ICICI Bank payment Gateway :

Please note that if Application Fee of Rs. 7,500/- (Seven Thousand Five Hundred only) is not paid on or before **23rd June**, **2025**, the candidature of candidate shall not be considered for admission. No further enquiry shall be entertained in this regard.

For Foreign Nationals merit shall be finalized on the basis of their percentage of marks in 10+2/ Intermediate or its equivalent. The Minimum percentage of marks in 10+2/ Intermediate or its equivalent required, for admission to B.A., LL.B. (Hons.) or B.B.A., LL.B. (Hons.) course is 45%. In case of any grading system, the equivalent percentage shall be taken into consideration. However, candidate shall fulfil other eligibility criteria of CLAT-2025. In case of tie, preference shall be given to higher percentage of 10th marks. In case of further tie, preference shall be given to the one with higher age. Further tie, if any, shall be done by drawing a lot.

The admission under NRI category for Non-Resident Indian candidates shall strictly be made on the basis of All India Rank (AIR) of CLAT-2025 which was organised by the Consortium of National Law Universities, Bangaluru on 01st December, 2024. Candidates have to fulfil eligibility criteria and guidelines of CLAT-2025.

Applicants under Foreign Nationals/NRIs, if provisionally selected for admission for UG Course for the Academic Year 2025-26 shall complete the admission process by complying with the notified norms of the University.

The provisional admission list will be tentatively published on our University website i.e. <u>https://cnlu.ac.in/admission-process/</u> and the provisionally selected candidates will be informed through website/email.

The classes for newly admitted UG students for the First Semester, Academic Year 2025-26 will commence from Tuesday, the 01st July, 2025.

- (i) Unfilled seats of the Foreign Nationals / NRIs shall not be filled in by any other categories and they shall remain vacant.
- (ii) Notification regarding payment of University fee will be notified latest by 06th June, 2025 on the University website i.e. https://cnlu.ac.in/admissionprocess/
