Scope of work:

- The scope of work will be as per the work description mentioned in Annexure-II. (Boys' Hostel, Girls' Hostel, VC & Registrar Residence, Type-I, II, IV Quarter and Narmada Guest House.
- Detail Scope and area measurements are provided in Annexure-II.

Eligibility Criteria

1. Participating Firms/ Company should have a valid pest control license for the current year issued by the Agriculture Department, Govt. of Bihar. Scanned copy to be uploaded.
2. Participating Firms/ Company should have a GST number. Scan copy to be uploaded.
3. Participating Firms/ Company should have at least one single work completed worth Rs. 3,00,000/- in Govt. Department / reputed Institution in the last three financial years. Completion certificate issued by concerned Executive Engineer / Concerned Authority must be uploaded.
4. Scan copy of Income Tax Return (ITR) of last three financial year i.e., 2022-23 to 2024-25.
5. Scan of Affidavit as per Annexure-I on Rs. 100/- Indian Non-Judicial Stamp.

Chemicals to be used for

1. **Termite Control** – Imidachloprid 30.5% SC / Imidachloprid 39.5 SC / Chlorpyrifos 20% EC, Dose – As per manufacturer's recommendation. (The name of any of these insecticides shall be in the Pest Control Licence issued by the Agriculture Department, Govt. of Bihar.

Payment Terms

1. Payment will be made based on actual measurement and satisfactory performance certificate from competent authority.
2. All payments are subject to deductions as per Government Rules.

Terms & Condition

1. All documents should be signed by the proprietor or an authorised signatory of the firm. Original Certificate of authorisation should also be attached. Interlineations, corrections, erasures and/or over-writings shall be valid only if initiated by the person or persons signing the quotation.
2. Quotationers are advised to be present in the meeting of Pre-Bid, and Technical Bid.
3. The quotationer should adhere with all seriousness to the time schedule provided by the Chanakya National Law University, Patna.
4. Rejection of Quotations: Canvassing by the Quotationer in any form, unsolicited letter and post Quotation correction may invoke summary rejection. Conditional Quotations will be rejected.

5. Any Suggestions/Clarifications may be put forth in the pre-bid meeting.
6. Joint ventures will not be allowed to participate in this tender.
7. The quotationer shall be liable to indemnify the Chanakya National Law University, Patna in all respects and meet and pay off the litigation expenses and all the liabilities including damages, sums etc. arising out of and as a consequence of the negligence, deficiencies, mistakes, lapses, delays etc. in the execution of the various jobs and the services provided.
8. Single anti termite treatment will remain effective for up to 4 years. In case of failure, no additional payment shall be made to the agency for re-treatment and penalty will be imposed accordingly.
9. All types of damages, which are essential for doing anti -termite treatment shall be repaired with good finishing by the service provider itself without charging any amount.
10. All statutory deductions including TDS shall apply.

11. Technical Bid Evaluation Process:

- Detailed technical evaluation shall be carried out in relation with the conditions in the quotation document to determine the substantial responsiveness of each quotation. For this clause, the substantially responsive quotation is one that conforms to all the eligibility and terms and conditions of the quotation without any material deviation.
- The evaluation committee may call the responsive quotationer who complies with all Eligibility of the quotation for discussion to facilitate and assess their understanding of the scope of work and its execution.
- It is mandatory for the bidder to qualify all the technical qualifications (including eligibility criteria) to be responsive and for being considered for opening of their Financial Quotation and evaluation thereof.

12. Dispute if any, will be subject to Patna jurisdiction only.

13. The work order placed is liable to be cancelled at any time if any document submitted by the agency is found fake and misleading.

14. Amendment of Quotation Document.

- A. At any time prior to the last three days for receipt of quotations, the client may for any reason, whether at its own initiative or in response to a clarification requested by a prospective Quotationer, modify the Quotation Document by an amendment.
- B. The amendment will be notified through the official website of Chanakya National Law University for all the prospective Quotationers.
