2. Eligibility Criteria: Bidder having the below mentioned documents shall be eligible for participating in this tender. List of documents are as mentioned below:

- i Architect / Consultant/firm must be registered with Council of Architecture and shall have to submit scanned copy of valid registration certificate along with EOI.
- ii Duly signed & stamped scan of document in which Name of the Firm, Address with contact number, E-mail of the Firm and Firm's Bank Account Details with Bank Name & Address and IFSC / RTGS codes mentioned.
- iii Copy of PAN card (in name of Proprietor in case of Proprietorship Firm) GST certificate

6. Qualification of the Bidder

- The determination shall be based upon on examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder. The determination shall not take into consideration the qualifications of other firms such as the Bidder's subsidiaries, parent entities, affiliates, subcontractors, or any other firm different from the Bidder.
- If a Bidder does not meet the qualifying criteria specified in (i) above its Bid shall be rejected by CNLU and may not subsequently be made responsive by correction of the material deviation, reservation, or omission.
- Only Bids that are both substantially responsive to the bidding document and meet all the Conditions of Eligibility and Qualification Criteria shall have their "Financial Part" submitted in e-portal opened.
- The bidders are directed to submit valid work orders/Agreement with Employer/s along with proper work completion certificate against experience credentials.

7. To evaluate the Financial Part, CNLU shall consider the following:

The Bid price

- i price adjustment for correction of arithmetic errors
- ii price adjustment due to discounts offered
- iii converting the amount resulting from applying (i) to (ii) above, if relevant, to a single currency, for evaluation and comparison purposes.
- iv price adjustment due to quantifiable nonmaterial nonconformities

8. In evaluating the Financial Part of each Bid, the Employer shall correct arithmetical errors on the following basis:

- i only for admeasurement contracts, if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of CNLU there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

9. Bidders shall be requested to accept correction of arithmetical errors. Failure to accept the correction shall result in the rejection of the Bid.

10. In the event of identification of a potentially Abnormally Low/High Bid, CNLU shall seek written clarifications from the Bidder, including detailed price analyses of its Bid price in correlation to the subject matter of the contract, scope, proposed methodology, schedule, allocation of risks and responsibilities and any other requirements of the bidding document.

11. If the Bid for an admeasurement contract, which results in the lowest evaluated cost, in CNLU's opinion, seriously unbalanced or front loaded CNLU may require the Bidder to provide written clarifications. Clarifications may include detailed price analyses to demonstrate the consistency of the Bid prices with the scope of works, proposed methodology, schedule and any other requirements of the bidding document.

12. Terms and Conditions:

- i Tender document shall not be acceptable through post, courier or any offline mode. Interested bidders are advised to submit the bid only through our e-Tendering portal.
- ii Scanned documents as mentioned in Eligibility criteria is mandatory. Bidder should upload all the scan of genuine documents otherwise their technical bid shall be declared non responsive.
- iii Original document of Affidavit as per Annexure-I should be submitted by bidder during opening of Technical Bid.
- iv The price will be remain firm and fixed during the pendency of contract. It will not vary on any account including revision of taxes, imposition of new tax or any contingency whatsoever.

- viii Incomplete bid and bid without genuine documents are liable for rejection. No responsibility will be taken for any type of technical glitch while online submission of bid
- ix Notwithstanding anything to the contrary in this document, Chanakya National Law University is not bound to accept the lowest bid and reserves the right to accept or reject any bid, to reject bids for some or all items and to cancel the bidding process at any time prior to the award of contract, without assigning any reason whatsoever.
- x University will not provide any residential facility to workers / authorities of successful bidder inside campus. Firm will make temporary shade inside campus. Water and electrical facility for such shade will be chargeable.
- xi The work is required to be completed within the period mentioned against the works i.e. **within 30 days**. It will be reckoned from the date of the issue of work order after agreement. If the work is not completed within the stipulated completion period liquidated damages @ 0.5% of agreement value per day of delay will be levied (subject to maximum of 10%). If the liquidated damages reach the level of 10% the agreement value the contract is liable to be rescinded.
- xii Work shall be done strictly as per specification and direction of competent authority of CNLU, Patna.
- xiii Dispute, if any, will subject to Patna Jurisdiction only. The decision of Vice-Chancellor, CNLU will be final and binding with both the parties viz: bidder and the University. xvi) Price should be quoted in Indian Rupees only. The price will remain firm and fixed during the pendency of Contract and will not be changed for any reason (including revision of taxes & levies whatsoever).
- xiv All labour laws & regulations are to be followed by the bidder.
- xv The bidder shall be bound to follow the restriction on the movement of labour, materials imposed by any other authority connected with the site due to security or any other reasons connected with the event. No claim shall be entertained on this account.
- xvi The bidder shall take all precautions to avoid accidents by exhibiting necessary cautions boards, lights, flags etc. and ensure that no hindrance is caused to the traffic. Bidder shall be responsible for all damages, accidents, caused due to negligence.
- xvii The contractor shall arrange all tools and plants necessary for the execution of the work at his own cost. Any loss or damage in this case will be to his account.
- xviii Lowest responsive bidder will be considered on the total amount of bids of the respective work.
- xix Technical officers/Staff deployed by the Contractor / Firm at CNLU any construction site will also be responsible for inferior quality/Poor performance of any work and their names will be circulated to all works departments to debar them from any other site.
- xx All the risks of loss of or damage to physical property and of personal injury and death which arise during and in consequence of the performance of the contract other than the expected risks will be the responsibility of the contractor/ firm.

- i **Applicable TDS** will be deducted from the bill of total amount without tax as per the provision of Government of India and certificate for the same will be issue,
- ii **Applicable amount** will be deducted from total GST.

15. Agreement and Performance Security:

- i Successful bidder/consultant will be issued a letter of acceptance. After receipt successful bidder shall enter into the agreement on PWD Form F2 failing which on **Rs. 1,000.00 (Rupees One Thousand) non judicial stamp paper** within (10) **ten working days** from the **date of issue of work order**.
- ii EMD @ 2% shall have to be deposited by the selected Consultant / Architect / Firm at the time of agreement. In addition to EMD, Security Deposit (SD) shall have to be deposited as per Bihar Govt. norms applicable in case of consultants.
