## **General Conditions:**

1. The UGC prescribed qualifications and experience are minimum and the mere fact that an applicant possesses the same will not entitle him / her for being called for interview. The University reserves the right to restrict the applicants to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit. Those who are possessing higher qualifications will be given preference. The University may constitute a Screening Committee to scrutinize the applications and short-list the applicants. Call letter for interview will be sent only to the short-listed applicants and no correspondence will be entertained with applicants who are not short-listed.
2. The University on the recommendation of the Selection Committee may offer a lower post such as Research Associate, Teacher Associate, Lecturer etc. to an applicant who may have applied for a higher post depending on his/her performance in the Selection Committee for the advertised posts.
3. Applications incomplete in any respect shall not be considered at all.
4. The University reserves the right to increase the positions or fill all the positions advertised or fill-up some of the positions or not to fill any of the positions.
5. University will make all correspondence only through email.
6. In case of any disputes / suits or legal proceedings against the University, the Jurisdiction shall be restricted to the High Court of Judicature at Patna.
7. The reservation roster as prescribed by Govt. of Bihar shall be followed.
8. The applicant must be a citizen of India.
9. Preference will be given to the applicants who have the experience of teaching in National Law Universities.
10. Applicants shall have to produce original documents at the time of interview.
11. Canvassing in any form/bringing in any influence political or otherwise will be treated as a disqualification for the Post.
12. The shortlisted applicants will be intimated only through email.
